Assisted Living Statistics*

- Total Number of Participants on Global Options – 11,852
 - Of those, the total number in Assisted Living – 3,141
 - ALR - 2,263
 - CPCH - 591
 - ALP- 287
- Approximate number of Assisted Living providers:

2014 AL Provider Medicaid Waiver Reimbursement

- Room and Board from the participant
 - (ALR/CPCH CY '14 \$764.05)
 - (ALP resident pays subsidized housing rent, utilities and food)
- Medicaid per diem reimbursement for services
 - \$70 /day – ALR
 - \$60/day – CPCH
 - \$50/day – ALP
- Participant may also have a Cost Share, which is deducted from the amount that provider bills Medicaid
- Supplementation for Room and Board, paid by a Third party only (for accommodations only)

MEDICAID WAIVER ASSISTED LIVING SERVICES

Services Included in ALR (\$70 per diem)/CPCH (\$60 per diem)

- Core package of AL services:
 - personal care, chore, attendant care, laundry, medication administration, social activities, skilled nursing, on-going assessment, health monitoring, and transportation for medical appointments, directly or through arrangement with an outside provider
- Regular array of Medicaid State Plan services (Health Insurance) with certain exceptions:
 - No PCA, NF, ADHS, SADC
 - GO Waiver Service of Social Day Care is allowed in ALP only
- Monthly cost for the above services = \$2,100.00 – ALR
- Monthly cost for the above services = \$1,800.00 - CPCH

Services Included in ALP (\$50 per diem)

Core package of ALP services:

- personal care, chore, attendant care, laundry, medication administration, social activities, skilled nursing, on-going assessment, health monitoring, and transportation for medical appointments, directly or through arrangement with an outside provider

Regular array of Medicaid State Plan services (Health Insurance) with certain exceptions:

- No PCA, NF, or ADHS

If re-evaluation shows need and Care Manager authorizes, participant may attend limited Social Adult Day Care (\$31.12 per diem) and/or receive Home Delivered Meals (approx.\$10.00 per meal) and/or receive a Personal Emergency Response System (PERS) at \$29.00 per month

Care Management \$95 per month

Monthly Cost for above services (ALP, SADC, PERS, HDM) = \$2,173.96

Includes ALP per diem, CM, 8 units of SADC, 1 PERS, 30 HDMs

Medicaid Waiver Participants Receiving GO services In A Home Setting - Scenarios of Service Delivery

Scenario One: ADHS and HBSC (Agency)

- ADHS $\$78.50 \times 5$ days per wk. (5 hrs. per day) = $\$392.50$ ($\$1,570$ Mo.)
- HBSC (M-F) $\$15.50 \times 10$ hrs. per wk. = $\$155$ ($\$620$ Mo.)
- HBSC (S or S) $\$17 \times 5$ hrs. per wk. = $\$85$ ($\$340$ Mo.)
- Care Management fee = $\$95$ per month
- Monthly Total = $\$2,625$ (ADHS, HBSC, CM)*

Scenario Two: HBSC (Agency)

- HBSC (M-F) $\$15.50 \times 30$ hrs. per wk. (6 hrs. per day) = $\$465$ ($\$1,860$ Mo.)
- HBSC (S-S) $\$17 \times 10$ hrs. per wk. = $\$170$ ($\$680$ Mo.)
- Care Management fee = $\$95$ per month
- Monthly total = $\$2,635$ (HBSC & CM)*

*totals based on a 4 week month
