To: Providers of Procedure Codes Impacted by Electronic Visit Verification

Re: Electronic Visit Verification (EVV) – Gainwell Billing Codes

To Whom It May Concern:

In 2016, Congress passed the 21st Century Cures Act, which requires the use of Electronic Visit Verification (EVV) for all Medicaid-funded personal care services requiring an in-home visit. This includes the following services through the Division of Developmental Disabilities (Division) that require an in-home visit:

However, the Centers for Medicare and Medicaid Services (CMS) allows for the following EVV exemptions:

- CMS allows the exclusion of EVV when the person providing care is living with the person receiving care. In this case, there is no "visit" to record as required by the 21st Century Cures Act because the provider is living in the home. This exemption applies to both family members and non-family members.
- CMS interprets the reference in the statute to an "in-home visit" to exclude personal care attendant (PCA) services provided in congregate residential settings where 24-hour service is available. This includes settings such as group homes, supervised apartments, and supported living.

When billing Gainwell, it will be necessary to choose the correct "Place of Service" code to indicate if the service provided requires EVV. This code can be found on form 1500 (837) in section 24B (please see below).



Please see the below list of applicable CMS Place of Service Codes:

CMS Place of Service Code Set

Service Code to be placed on the 837/1500	Service Location	EVV Applicable/Not Applicable
12	Home	EVV Applies
14	Congregate Care (GH, SA, SL)	EVV does not apply
02	Telehealth (virtual services)	EVV does not apply
18	Place of Employment	EVV does not apply
99	Other	EVV does not apply Examples: Live-In Caregiver Respite in any setting other than the individual's Home

Providers should begin submitting claims using the correct CMS Place of Service Codes immediately. The correct Place of Service Code usage is imperative to ensure that the data being submitted to CMS is accurate and that providers will not experience any payment delays.

At this time, providers do not need to modify claims already submitted that have the EVV procedure codes.
