RESPONDENTS.

As Director of the Division of Medical Assistance and Health Services, I have reviewed the record in this matter, consisting of the Initial Decision, the documents in evidence and the entire contents of the OAL case file. No exceptions to the Initial Decision were filed. Procedurally, the time period for the Agency Head to render a Final Agency Decision is June 20, 2016, in accordance with N.J.S.A. 52:14B-10 which requires an Agency Head to adopt, reject, or modify the Initial Decision within 45 days of the agency's receipt. The Initial Decision was received on May 5, 2016.

Pursuant to 8 U.S.C. §1612 and §1613 and N.J.A.C. 10:69-3.9(c)1, a legal

alien who entered the country after August 22, 1996 is not eligible to receive

Medicaid benefits for a period of five years. Petitioner received her permanent

resident card on May 25, 2011. Nevertheless, the Cumberland County Board of

Social found her temporarily eligible for benefits pursuant to a domestic violence

waiver. However, the waiver expired and the County sought to terminate

benefits as of December 31, 2015.

Since Petitioner received her permanent residence card on May 25, 2011,

five years had not elapsed as of December 31, 2015 and thus the termination

was appropriate. However, as of May 25, 2016, Petitioner satisfied the five-year

residency requirement and may now be eligible for benefits. I suggest she

submit an application with the Cumberland County Board of Social Service or

through the Health Insurance Marketplace.

That the Initial Decision affirming the termination of Medicaid eligibility is hereby ADOPTED.
