**ORDER OF REMAND** 

DIVISION OF MEDICAL ASSISTANCE:

RESPONDENTS.

As Assistant Commissioner for the Division of Medical Assistance and Health Services, I have reviewed the record in this case, including the Initial Decision and the Office of Administrative Law (OAL) case file. No exceptions were filed in this matter. Procedurally, the time period for the Agency Head to render a Final Agency Decision is November 22, 2021 in accordance with an Order of Extension.

This matter arises from Monmouth County Division of Social Services's (MCDSS) May 19, 2021 determination that Petitioner was eligible for Medicaid benefits beginning on April 1, 2021.<sup>1</sup>

Upon reviewing the documents contained in the OAL file, it was discovered that the Appendix to the Initial Decision lists the following exhibits as being marked into evidence at the hearing in this matter: RR-1: Fair Hearing Request; RR-2: Notice of Hearing; RR-3: CP-2 Referral from CWA; RR-4: Email with CP-2 from CWA; RR-5: DoAS COVID19 Clinical Eligibility Communication for LTC Provide, July 1, 2020; RR-6: Bell Terra email Correspondence; RR-7: NJAC 8:85-1.8; RR-8: Policy Memorandum, AL Referral Form; RR-9: Medicaid Communication No. 16-09; RR-10A: NJMMIS PAS Screen; RR-10B: NJMMIS Financial Eligibility Screen; RR-10C: NJMMIS Managed Health Care Screen; RR-10D: NJMMIS Special Program Screen; RR-11A: AL-6 Referral Form; RR-11B: AL-6 Instructions; RR-12: DoAS COVID -19 Communication for Providers, March 20, 2020; and RR-13: DoAS COVID-19 Clinical Eligibility and PASRR Communication for LTC Providers, March 22, 2021. However, none of these referenced exhibits were included in the OAL case file. In order to settle the record, I am remanding the matter to OAL for the purpose of producing the referenced exhibits for inclusion in the OAL case file. See N.J.A.C. 1:1-18.1 and N.J.R. 2:5-5(B).

Upon production of the missing exhibits, the matter, with the complete case file, should be returned to the agency to render a Final Agency Decision.

THEREFORE, it is on this19thday of NOVEMBER 2021, ORDERED:

R-8. However, Petitioner is not contesting the penalty imposed and is only contesting the date of eligibility in this matter.

That the Initial Decision is hereby REMANDED solely to settle the record and provide the missing exhibits that were entered into evidence below for the inclusion in the OAL case record.
