As Assistant Commissioner of the Division of Medical Assistance and Health Services, I have reviewed the record in this case, including the Office of Administrative Law (OAL) case file and the Initial Decision approving the Settlement Agreement reached by the parties. No exceptions were filed in this matter. Procedurally, the time period for the Agency Head to render a Final Agency Decision is July 26, 2021 in accordance with an Order of Extension.

This matter concerns the reduction of Petitioner's personal care assistance (PCA) hours. By way of settlement, the parties agreed to resolve the issues surrounding the PCA hours, withdrawing the request of a fair hearing.¹

¹ The Settlement Agreement provides that Petitioner's PCA hours will be reassessed after the Governor of the State of New Jersey lifts COVID-19 restrictions that prohibited the reduction of PCA hours. However, I note that it was the Division of Medical Assistance and Health Services (DMAHS) that issued guidance, on March 30, 2020, which provided that all
