**TO:** NJ FamilyCare Eligibility Determining Agencies

**SUBJECT:** Case Number Series for Aged, Blind and Disabled Medicaid Recipients

Individuals determined eligible for medical assistance are assigned a unique twelve-digit identification or case number. The third and fourth digit of the case number represents the individual's Title XIX Medicaid program.

In order to accommodate the growth of new recipients, the programs identified under 10, 20, and 50 have been expanded but are not changing their original definition. There is no change to benefits or billing practices. The issuance of these new case numbers went into effect on November 17, 2025.

- Aged related programs under Program 10 have been expanded to include 11 and 13
- Disabled related programs under Program 20 have been expanded to include 21 and 23
- Blind related programs under Program 50 have been expanded to include 51 and 53

County Social Service Agencies should continue to assign and utilize case numbers identifying programs 10, 20 and 50 as available. The expanded case numbers described above will be reserved for use by the State's claims vendor, Gainwell Technologies, who will generate case numbers using 11, 21, and 51. The Integrated Eligibility System (IES), or Worker Portal, will generate case numbers using 13, 23, and 53 through the automated Medicaid Eligibility System (MES) upload.
