#### **Minutes**

- I. Administrative Issues/Correspondence
  - A. Attendance: 18/39 participants, 46.1%
  - B. Review of Previous Meeting Minutes: Minutes approved with minor edit.
  - C. Additional Federal Funding for Behavioral Health
    - 1. \$1.5B block grant funds
    - 2. \$1.5B additional funding for education
    - 3. Additional federal funding for BH services
    - 4. Additional federal funding to enhance BH workforce

#### II. State Partners Involvement (Phil Lubitz)

- A. SHA (Diane Riley)
  - 1. Additional funding in COVID relief, possible Infrastructure Bill brings more capital and operating funding opportunities.
  - 2. 15% state increase in housing investment however shifting in program investment. For example less in Affordable Housing Trust Fund and investment in homeownership and workforce housing. No new mental health subsidies but increases in voucher payment standards to upgrade to current rent levels.
  - 3. Assessing additional funds and impacts on housing
  - 4. This is on the SHC website: "DHS distributes all new rental subsidies and makes the determination of who is eligible to receive them. There are no new rental subsidies available at this time." Supportive Housing Connection (SHC) manages vouchers, leases etc. They do not approve vouchers or distribute vouchers.

- Q (J. Guttstein): Small area FMRs? (allows for more impactful payment standard) A: No. During pandemic, lots of peoples income as changed, so the Department picks up the outstanding balance, so FMRs will not be expanded. This issue is a matter of advocacy we should be working on. It should be mirroring HUD as much as possible.
- Q (J. Barugel): Is there a single source where one can 'wrap one's arms around this'?

A: As a consumer there is no one single place. I tell them: do you have Medicaid; do you have this/that? Have you applied to a housing voucher? Have you gone on to various websites to look for affordable opportunities there? Have you gone to a provider that providers supportive housing? A few housing resources on SHA website under Housing Hub which includes resource bulletins, and housing search. SHA NJ will be releasing an expanded resource directory of members with search ability by geography, service and programs.

Q: Can you also connect people with their local Continuum of Care that have coordinated entry? Challenge is for individuals who aren't homeless, so perhaps that is the issue in this instance.

A: Sign up for Homeless System via the County Continuum of Care.

Q: In the light of new federal funding, will there be better opportunities for housing? A: Yes, but there will always be a waiting list, although it should move faster with additional funding.

Q/Comment (Heather Simms): In Jersey City we have had Housing Navigators and HomeFinders. There should be someone who can assist. A: Housing navigators would be a great presentation. SHA has provided training around housing navigators (about 70% are DDD providers). Housing navigators are listed under Housing Hub.

Q/Comment: Robin Nyland: County Mental Health Analysts can help, and often know how to connect, Supportive Housing Coalition (SHC) can help.
