#### **III.** System Partner Updates (Darlema Bey)

- A. Division of Mental Health and Addiction Services (DMHAS) DMHAS (D. Migliorino)
- B. Children's Systems of Care (Diana Salvador).

- 1. CCIC Building Capacity Project: CSOC secured ARPA MHBG funding to implement the CCIS Building Capacity project designed to increase capacity of child and adolescent state subsidized inpatient units to more effectively treat a more diverse population including, but not limited to, youth with I/DD needs and LGBTQ+ youth. In doing so, CSOC partnered with Rutgers UBHC to conduct a training needs assessment of each unit and mobilize training and technical assistance in targeted areas. A Family Advisory Board of caregivers with lived experience was established to support the integration of youth and family voice in the offerings. Lastly, the project enabled the establishment of a reoccurring CCIS Medical Directors Meeting to support direct communication between unit and CSOC leadership.
- 2. Child & adolescent inpatient capacity: Although the number of available inpatient beds may seem insufficient, monthly census data reflects that units are rarely at capacity. However, the data does not account for daily and weekly trends that may impact access to beds at the time they are needed.
- 3. IDD Friendly child and adolescent inpatient units: SAMHSA
  Transformational Training Initiative funding was secured for CSOC to
  support the development of a training and toolkit for inpatient units that
  would increase their capacity to more effectively treat youth with
  intellectual and developmental disabilities and acute behavior challenges.
  In doing so, CSOC will create optional IDD Friendly Designation criteria
  for inclusion in the biannual CMS Biannual Redesignation process.
- C. Division of Developmental Disabilities (Jonathan Sabin)
  - 1. On October 23, 2024 DDD, The New Jersey Department of Human Services' Division of Developmental Disabilities announced the release of an updated Request for Proposals (RFP), To Support the Development of Homes for People with Intellectual and/or Developmental Disabilities Transitioning from Nursing Facilities and Other Qualified Institutions. Successful bidders will develop new residential opportunities to support people to move from nursing facilities into community-based residential homes. Funding may be used to develop new sites or enhance existing locations (update accessibility and/or complete other modifications to facilitate appropriate support for a person who is moving from a nursing facility or other qualified institution).

- D. Division of Vocational Rehabilitation Services (John Tkacz)

- 1. DVRS provided an overview of their services. Any individual with a physical, mental, cognitive, or other form of disability who has a substantial impediment to employment may qualify for the following services through the New Jersey Division of Vocational Rehabilitation Services (DVRS).
- 2. The mission of the New Jersey Division of Vocational Rehabilitation Services is to enable eligible individuals with disabilities to achieve an employment outcome consistent with their strengths, priorities, needs, abilities, and capabilities.
- 3. The law requires that we keep all paperwork and information about clients, including conversations, private, with a few exceptions. If a client chooses to disclose to their employer their disability it is their choice, DVRS respects the person's privacy. DVRS is allowed to release information about a person only when they get written permission from the client (or the person's parent, guardian, or designated representative).

  The NJ Division of Aging Services has funded organizations in every county to assist hands-on with NJSAVE applications. NJSAVE is one application for pharmaceutical, energy, Medicare, and hearing aid assistance. NJSAVE is available for anyone who is 65+ or younger and disabled.
