The New Jersey Department of Human Services' Division of Developmental Disabilities is pleased to announce the release of a new Request for Proposal (RFP) to Support the Development of Homes for People with Intellectual and/or Developmental Disabilities Transitioning from Nursing Facilities and Other Qualified Institutions. - 2. The Department of Human Services is enhancing the statewide emergency services programs that support adults with intellectual and developmental disabilities. The Department has awarded contracts to Community Options, Inc., Community Access Unlimited and Oaks Integrated Care to operate emergency capacity services (ECS) programs throughout the state. ECS programs support individuals with intellectual and developmental disabilities (I/DD), including those with acute behavioral needs who require immediate residential and day program support. This funding enables emergency, short-term support to be available for admissions seven days per week, 365 days a year with 24-hour coverage provided.

Reminder, DHS is still accepting submissions for its RFP for the provision of capital funds to offset costs incurred in the acquisition, development and renovation of group homes that serve newly placed individuals with acute behavioral and/or medical needs.
