Policy: CODI provides supportive housing with individualized case management services for individuals with a history of a serious opioid use disorder who are homeless or at risk of homelessness.

Procedure: Applicants for Supportive Housing OUD Community Support Services must meet the following criteria:

- 1. Must be eighteen years of age or older
- 2. Must provide documentation of a serious history of opioid use
- 3. Must require active rehabilitation and support services to achieve the restoration of functioning to promote the achievement of community integration
- 4. Must not have adequate resources and supports to live safely in the community
- 5. Must provide documentation of homelessness or being at risk of homelessness

CODI shall not discriminate in the provision of services in whole or in part, based an individual's race, color, creed, religion, sex, gender nonconformance, actual or perceived sexual orientation or gender identity, ancestry, age, national origin, marital status, domestic partner or civil union status, military status, political belief, atypical hereditary cellular blood trait, disability including alcoholism or substance use disorder, obesity, HIV and/or AIDS who may or may not be in treatment and/or recovery from an OUD substance addiction with legitimately prescribed medication[s]such as MAT) or other status protected by federal, state and/or local law.

Policy: CODI shall accept referrals via online application and determine if applicant meets enrollment and admission criteria.

Procedure: The following procedure for enrollment and admission shall apply:

- 1. Names of individuals referred for admission, in conjunction with a history of relevant information [e.g., opioid use history, documentation of homelessness or risk of homelessness] shall be forwarded to CODI's OUD Program Manager.
- 2. Upon receipt of referral, OUD Program Manager shall complete an Initial Assessment and forward results within five days of receipt of referral to CODI's Residential Admissions Team.
- 3. Admission Team shall be composed of OUD Program Manager, Supportive Housing Coordinator, VP of Residential Services, and President/CEO.
- 4. The Team shall review each case and by a simple majority of those present decide whether or not to admit the referral.
- 5. If referral is approved, OUD Program Manager shall schedule admission. If the committee recommends denial of service, OUD Program Manager shall notify applicant or referral source of decision and explanation of denial. OUD Program Manager will provide applicant with information regarding other community resources.
- 6. OUD Program Manager shall coordinate admission for approved referrals.
