P.L. 2009, chapter 161 requires that state psychiatric hospitals report major and moderate injuries among patients; and staff members and the number of unexpected deaths at these five designated facilities. The website created by Department of Human Services, posts additional categories of incidents beyond that required by the statute, to include minor incidents among this group of individuals as part of its efforts to promote transparency. Additionally, the website posts deaths of state hospital patients who may be in general medical facilities or on brief visits not yet discharged from the hospital.

This report includes substantiated incidents only.

Data is subject to update on a quarterly basis as information becomes available.
