




**Alcohol Use by Cape May County IDRC Clients Compared with 2003 NJ Household Survey**




**Number of Alcohol-Related Offenses on DMV Records of Cape May County IDRC Clients**



**Lifetime Marijuana, Cocaine and Heroin Use by Cape May County IDRC Clients Compared with 2003 NJ Household Survey**




