


Data were collected on 1,355 clients in 2009 who went through the Gloucester County Intoxicated Driver Resource Center program or were monitored by the Gloucester County IDRC. Information was gathered from a mandatory self-administered questionnaire given during the IDRC classes and the counselors' screening/evaluation scoring forms.




Alcohol Use by Gloucester County IDRC Clients Compared with 2003 NJ Household Survey




Number of Alcohol-Related Offenses on DMV Records of Gloucester County IDRC Clients



Lifetime Marijuana, Cocaine and Heroin Use by Gloucester County IDRC Clients Compared with 2003 NJ Household Survey




