New Jersey Department of Human Services Division of Mental Health and Addiction Services Substance Use Treatment Provider Performance Report July 1, 2022 - June 30, 2023

Welcome to the Statewide Substance Use Treatment Provider Performance Report issued by the New Jersey Division of Mental Health and Addiction Services (DMHAS) for all substance use disorder treatment providers licensed by the Department of Health.

The Senate and General Assembly of the State of New Jersey enacted an Act concerning substance use treatment facility performance (N.J.S.A. 26: 2G-38) requiring the annual preparation of Substance Use Treatment Provider Performance Report. The performance report shall show and compare the overall performance of each substance use treatment provider in the State with the Statewide average performance based on national outcome measures for each level of care. The division shall use the national outcome measures (NOMs) identified below and, as appropriate, any other national outcome measures identified by the Substance Abuse and Mental Health Services Administration. The performance report shall include the following national outcome measures: (1) percentage of clients abstinent from alcohol on admission and discharge; (2) percentage of clients abstinent from drugs on admission and discharge; (3) percentage of clients employed on admission and discharge; (4) percentage of clients enrolled in school or a job training program at admission and discharge; (5) percentage of clients who are homeless on admission and discharge; and (6) average length of client treatment.

According to the New Jersey Substance Abuse Monitoring System (NJSAMS), an administrative data collection system for clients who receive substance use treatment in New Jersey, there were 84,516 admissions to addiction treatment from 7/1/2022 to 6/30/2023. Of these admissions, 45,505 clients were unduplicated. For these unique clients, 27,300 had 1 admission, 9,308 had 2 admissions, and 8,897 had 3 admissions or more during this reporting period. It should be noted that multiple admissions may be reflective of a client's movement from one level of care to another, and not necessarily a relapse. The primary drug of choice and focus of substance use disorder treatment at admission was heroin or other opiates (42%), followed by alcohol (39%) and cocaine (7%). The most common levels of care were intensive outpatient (20%), detox residential (20%) and outpatient (20%), followed by short-term residential (13%), opioid maintenance-outpatient (13%), and long-term residential (7%). Males accounted for 69% of admissions with females comprising 31%. With regards to age, 1% were under 18, 2% were 18 to 21, 16% were 22 to 29, 46% were 30 to 44, 19% were 45 to 54, and 16% were 55 and over. For admissions, 58% were white, 25% were black and 15% were of Hispanic origin. The most common referral sources were self (58%) and corrections-related programs (16%), followed by addiction treatment programs (10%), and Intoxicated Driving Resource Center (5%). With regards to health insurance, 73% had Medicaid/NJ Family Care, 19% had private insurance and 10% were uninsured.

This performance report includes data on number of admissions and discharges, length of stay in treatment and performance on the national outcome measures for each provider as well as statewide performance. The domains of focus are: abstinence, employment, education/training, stability in housing and retention in treatment. The report is broken down by the level of care provided.

Outcomes are only reported if the agency had at least 20 discharges. The outcomes are based on data for the same client. That is, all discharges were selected for the reporting year and then the admission information for that discharge was linked in order to compute the outcome measures.

By publicly reporting these outcomes, the DMHAS hopes to provide consumers with information on the outcomes achieved so they can make informed decisions about choosing a provider and to help providers see how they are doing compared to their New Jersey peers and to the state so that they can identify areas that might need improvement.

These performance reports are one strategy that DMHAS has adopted in its continuous quality improvement efforts focused on helping to improve services to the clients we serve. The NOMs are one way to monitor client outcomes, help direct system improvements and achieve better accountability.

Definitions for the various Level of Cares presented in this report are described below.

Level of Care Definitions

Standard/Traditional Outpatient

Clinically directed screening, evaluation, treatment and ongoing recovery and disease management services are offered. Services are provided in regularly scheduled individual, group and/or licensed family counseling for less than 9 hours a week. Counseling provided on an individual or group basis includes therapeutic and supportive interventions is designed to: motivate the client for recovery from substance use disorder, facilitate skills for the development and maintenance of that recovery, improve problem solving and coping skills, improve intra- and interpersonal development and functioning, and develop relapse prevention skills. Counseling provided to the family unit, with or without the consumer present, imparts education about the diagnosed substance use disorder, elicits family support for the consumer's treatment, encourages family members to seek their own treatment and self-help, assesses the consumer's environment during or after treatment and assesses the consumer's functioning outside of the treatment environment.

Intensive Outpatient

Intensive Outpatient (IOP) treatment provides a broad range of highly intensive clinical interventions. Services are provided in a structured environment for no less than 9 hours per week. Counseling services include individual, group and family. Counseling provided on an individual or group basis includes therapeutic and supportive interventions is designed to: motivate the client for recovery from substance use disorder, facilitate skills for the development and maintenance of that recovery, improve problem solving and coping skills, improve intra- and interpersonal development and functioning, and develop relapse prevention skills. Counseling provided to the family unit, with or without the consumer present, imparts education about the diagnosed substance use disorder, elicits family support for the consumer's treatment, encourages family members to seek their own treatment and self-help, assesses the consumer's environment during or after treatment and assesses the consumer's functioning outside of the treatment environment. IOP treatment will generally include intensive, moderate and step-down components.

Partial Hospitalization

Partial Hospitalization treatment provides a broad range of highly clinically intensive interventions. Services are provided in a structured environment for no less than 20 hours per week. Programs have ready access to psychiatric, medical and laboratory services. A partial hospitalization program does not need to be attached to a licensed hospital.

Halfway House

Treatment is provided in a licensed residential facility which provides room, board and services designed to apply recovery skills, prevent relapse, improve emotional functioning, promote personal responsibility and re-integrate the individual into work, education and family life. It includes no less than 3 hours per week of counseling services. A minimum of 7 hours per day of structured activities must be provided on each billable day. Examples of structured activities include: Psycho-education, Employment, Vocational Training, Recovery Support Services, and Recreation.

Long-Term Residential

Treatment is provided in a licensed residential facility which provides a structured recovery environment, combined with professional clinical services, designed to address addiction and living skills problems for persons with a substance use diagnosis who require longer treatment stays to support and promote recovery. It includes no less than 8 hours per week of counseling interventions on at least five separate occasions. A minimum of 7 hours per day of structured activities must be provided on each billable day. Intervention focuses on reintegration into the greater community with particular emphasis on education and vocational development.

Short-Term Residential

Treatment is provided in a licensed residential facility which provides a highly structured recovery environment, combined with professional clinical services, designed to address specific addiction and living skills problems for persons who are deemed amenable to intervention through short-term residential treatment. It includes no less than 12 hours per week of counseling interventions on at least six separate occasions. A minimum of 7 hours of structured programming must be provided on a billable day.

Hospital-Based Residential

An organized service delivered by medical and nursing professionals, which provides 24-hour medically supervised evaluation and care in a permanent facility with inpatient beds. Services are delivered under a defined set of physician-approved policies and physician monitored procedures for clinical protocols. This level provides care to consumers whose acute biomedical, emotional or behavioral problems are severe enough to require primary medical and nursing services. Treatment is provided 24 hours a day, and the full resources of a general acute care hospital or psychiatric hospital are available.

Detox-Free Standing Residential

An organized clinically managed service delivered by trained staff who provide 24-hour supervision, observation and support for patients who are intoxicated or experiencing withdrawal. This level is characterized by its emphasis on peer and social support rather than medical and nursing care.

Detox-Outpatient (Ambulatory Withdrawal Management)

An organized service delivered in an outpatient setting with extended on-site monitoring by medical and nursing professionals who provide a range of services including medical and clinical interventions, laboratory testing, the dispensing and/or administration of approved medications provided to treat and monitor consumers undergoing withdrawal from drugs, including alcohol. This service is indicated when an individual experiences physiological dysfunction during withdrawal, but neither life, nor significant bodily functions are threatened. Per Diem services shall include, but are not limited to a minimum of 2 hours of on-site monitoring through face-to-face interactions with the consumer.

Opioid-Maintenance Outpatient

This level of care is provided by a licensed Opioid Treatment Program (OTP) and includes: Case Management, Medication Monitoring, Medication Prescribing and Dispensing, and Counseling Services that include individual, group and family therapy. Methadone, used for maintenance and/or detoxification is provided in combination with outpatient treatment. Methadone is a synthetic opioid used medically as an analgesic and as an anti-addictive medication for patients who meet the criteria for opioid dependence. Buprenorphine and Naltrexone are other options used medically for the treatment of opioid dependence. Outpatient methadone maintenance programs assign each client to one of six phases and provide counseling to the client in accordance with the phase requirements.

Opioid-Maintenance Intensive Outpatient

This level of care is provided by a licensed Opioid Treatment Program (OTP) that includes: Case Management, Medication Monitoring, Medication and Dispensing, and Counseling Services that include individual, group and family therapy. Methadone, used for maintenance and/or detoxification is provided in combination with intensive outpatient treatment. Methadone is a synthetic opioid used medically as an analgesic and as an anti-addictive medication for patients who meet the criteria for opioid dependence. Buprenorphine and Naltrexone are other options used medically for the treatment of opioid dependence. Outpatient methadone maintenance program(s) assign each client to one of six phases and provide counseling to the client in accordance with the phase requirements.
