In a Nutshell:

24% of NJ's 2023 population was aged 60 or older. 4% were aged 80 or older.

44.9% of the falls treated in the ED and released were among those aged 60 or older. 18.1% were among those 80 and older.

85.1% of falls admitted as inpatients were aged 60 or older; 47.7% were aged 80 or older.

49.6% of all falls treated in the ED or admitted were among patients aged 60 or older, and 21.5% were aged 80 or older.

3.8% of NJ residents aged 60 or older were treated and released in the ED for a fall. 9.2% NJ residents aged 80 or older were treated and released in the ED for a fall.

0.9% of NJ residents aged 60 or older were admitted to inpatient care for a fall. That percentage is more than tripled (3.1%) for NJ residents 80 or older.

4.7% of NJ residents aged 60 or older were treated in the ED or as inpatients for a fall, and 12.3% of NJ residents aged 80 or older.
