APS investigates reports of maltreatment and self-neglect, connecting eligible individuals with services to ensure their safety and well-being. Services focus on self-determination and using the least restrictive measures to help individuals remain in their homes whenever possible.

HOW DOES APS HELP?

Each county has a designated APS provider responsible for responding to reports of abuse, neglect, or exploitation by:

- Screening and investigating reports
- Meeting with individuals to assess their needs
- Recommending necessary services

CRITERIA FOR APS CASES

Vulnerable adults who meet all of the following criteria may be in need of APS:

A vulnerable adult is:

- **Age:** 18 years or older
- **Residence:** Living in the community
- **Vulnerability:** Unable to make, communicate, or carry out decisions concerning his or her well-being due to physical or mental illness, disability, or deficiency.
- **Risk:** Is the subject of abuse, neglect, or exploitation.

Community Settings Include:

- Private homes or other community settings that are not licensed or regulated by any State department or agency.

Note: Services are voluntary unless court ordered.

CONFIDENTIALITY

All records and communications related reports, evaluations, or services provided are confidential.

APS may only share information when directed by court order.



Adults retain all their civil and constitutional rights unless some of those rights have been restricted by court action.

REPORTING TIPS:

- Reports are made directly to APS provider in the vulnerable adult's county of residence.
- Provide detailed information, including the individual's name, address, and the concern.
- If possible, the person with firsthand knowledge should make the report.

LIMITS TO ASSISTANCE

- APS cannot force services on adults with capacity who decline assistance.
- APS cannot remove an individual from their home without consent or a court order.
- APS cannot impose restrictions unless ordered by a court.

MANDATORY REPORTING REQUIREMENTS:

New Jersey Adult Protective Services (APS) law requires the following professionals to report suspected abuse, neglect, or exploitation of vulnerable adults.

- All health care professionals (e.g., doctors, nurses, social workers, etc.)
- Law enforcement officers
- Firefighters, Paramedics
- Emergency Medical Technicians (EMTs)
