DEFINITION:	Under the close supervision of a Program Specialist 3, Program Specialist 4, or other supervisory officer in a State department or agency, as a trainee and productive worker, receives on-the-job training while assisting in the professional, administrative, and analytical work to promote the planning, operation, implementation, monitoring and/or evaluation of human or social service programs, programs serving the socio-economic needs of specific clients populations, or regulatory programs designed to ensure public safety, health and welfare, or protection of the environment; completes assignments which provide practical Program Specialist experience; does other related work.				
SPECIAL NOTE:	The full time specialist will be completing Hard of Hearing Specialist tasks. The employee will work with equipment and hearing aid program applications, demonstrate assistive devices, and conduct and coordinate workshops and conferences. In addition, the full time specialist will consult with clients, families, and agencies with regard to devices for effective communication, outreach to inform consumers of our services and programs, and prepare comprehensive statistical and other reports containing findings, conclusions and recommendations. The incumbent will prepare educational presentations on assistive listening devices, including an overview of the program.				
REQUIREMENTS:	NOTE: Applicants must meet one of the following or a combination of both experience and education. Thirty (30) semester hour credits are equal to one (1) year of relevant experience.  Four (4) years of professional experience relevant to the position. Experience must be related to the journeyman title associated with the position.  OR  Possession of a bachelor's degree from an accredited college or university.  NOTE: Appointees to positions assigned to the Weatherization Assistance Program in the Department of Community Affairs will be required to complete training and obtain a certification as a Quality Control Inspector, issued by an agency accredited by the United States Department of Energy (USDOE), in conformance with USDOE Weatherization Program Notice 14-4.  Training is required to be successfully completed subsequent to advancement to the primary title, Program Specialist 1, Socio-Economic Programs.  NOTE: "Professional experience" refers to work that is analytical, evaluative, and interpretive; requires a range of basic knowledge of the profession's concepts and practices; and is performed with the authority to act and make accurate and informed decisions.
