New Jersey Becomes 9th State Accepted into AARP Network of Age-Friendly Communities



Governor Murphy's Budget will raise the income limits for the **PAAD and Senior Gold programs by \$10,000 each**



DHS' Division of Aging Services will launch the **Age Friendly New Jersey initiative**, in partnership with AARP, to help support communities become accessible and inclusive places to live at any age



The Governor's Budget maintains **the 10 percent rate increase for Medicaid nursing facilities** with an investment of \$87 million in state dollars for a total of \$174 million after federal matching

New Jersey has become the ninth state accepted into the AARP Network of Age-Friendly Communities, which works to make communities supportive and accessible places to live for people of all ages.

"In New Jersey, we are making vital investments to help enhance the quality of life for everyone, including our older residents," Governor Phil Murphy said. "I'm honored to be recognized by AARP for our work and committed to building on our efforts to create more accessible and more inclusive communities."


Adelman said. "I thank AARP for approving our designation and look forward to working with them and communities and stakeholders across New Jersey to turn this plan into reality."

Governor's Budget Includes \$240 Million in Wage Increases for Workers Who Care for Individuals with Disabilities, Older Residents, Medicaid Beneficiaries & Children



Demonstrating continued support for the frontline workers who are vital to the health and safety of so many New Jerseyans, especially during the ongoing COVID-19 pandemic, Governor Murphy's budget proposal includes wage increases for workers who provide critical care for individuals with disabilities, older residents, Medicaid beneficiaries and children.

The budget plan for the fiscal year that starts July 1 includes about \$240 million for wage increases for direct support professionals, certified nurse aides, personal care assistants, Medicaid transportation providers and child care workers.

"Governor Murphy's budget continues to recognize the crucial work happening on the frontlines caring for individuals with intellectual and developmental disabilities, older adults, Medicaid beneficiaries and children across the state," Acting Commissioner Adelman said.

The Governor's proposed budget includes:

- \$83.4 million to support direct support professionals.
- \$134.4 million to continue and enhance wage increases for nursing facility direct care staff.
- \$157,000 to support wage increases in the Division of Aging Services' community-based programs for older adults.
- \$9 million to support Medicaid transportation providers.
- \$12.8 million to support the child care workforce.

"We are so grateful for the commitment of our child care workers as they have supported families throughout the pandemic," Human Services Deputy Commissioner Elisa Neira said.

Governor's Budget Plan Would Boost Hearing Aid Reimbursement for Qualifying Older Adults & Individuals with Disabilities

GOVERNOR MURPHY'S BUDGET INCREASES REIMBURSEMENT FOR HEARING AID PURCHASES



Human Services' Hearing Assistance Program currently provides a \$100 reimbursement per calendar year to offset the purchase of a hearing aid.



Under the proposed budget, individuals can be **reimbursed up to \$1,000 for hearing aid costs, \$500 per hearing aid, per calendar year.**



Governor Phil Murphy's budget plan for the fiscal year starting July 1 would significantly increase hearing aid purchase reimbursement available under the state's [Hearing Aid Assistance to the Aged and Disabled](#) program.

The program provides eligible individuals with a \$100 reimbursement to offset the cost of purchasing a hearing aid per calendar year. Governor's Murphy's budget plan for next fiscal year would increase the reimbursement to \$500 per hearing aid per calendar year. It would be the first increase since the program was created in 1987.

"The Governor's budget proposal is all about continuing to make New Jersey a stronger and fairer state that works for everybody, and that includes older adults and individuals with disabilities who need hearing assistance," Acting Commissioner Adelman said.

"This would be meaningful help to New Jersey residents in need of hearing aid assistance," Deputy Commissioner Neira said.

"Too many members of our deaf and hard of hearing community struggle to afford hearing assistance that is vital to their quality of life, especially older adults and those with disabilities," Division of the Deaf and Hard of Hearing Executive Director Elizabeth Hill said. "This increase would lead to better lives for those in need."

"This increase would mean so much to so many," Director Rush said.

NJ Human Services Delivers Extra May Food Assistance Benefits to 426,000 Households



NJ Human Services delivered extra food benefits for May to the 426,000 New Jersey households who receive food assistance through the state's Supplemental Nutrition Assistance Program ([NJ SNAP](#)). They received \$73.9 million in total extra benefits in May.

Human Services has been providing NJ SNAP households with maximum benefits since March 2020 when the pandemic began. Under a change implemented in April by the U.S. Department of Agriculture,

households that had already been receiving that maximum available SNAP benefit are also now also eligible for the temporary extra assistance.

A 15 percent increase in SNAP benefits also remains in effect through September.

Human Services has now distributed \$694.1 million in supplemental monthly SNAP payments to households since March 2020.

“We’re committed to providing as much additional food security as possible to New Jersey families for as long as possible,” Acting Commissioner Adelman said. “These additional food assistance benefits will again prove vital to many New Jersey households as this public health emergency continues.”

“We’re dedicated to helping as many families as we can as this challenging time continues,” Deputy Commissioner Neira said. “We will continue taking advantage of all available resources to help New Jersey households afford groceries as much and for as long as we can.”

NJ Human Services Seeks Proposals for New Community-Based Program for Individuals with Intellectual and/or Developmental Disabilities and Co-Occurring Behavioral Needs



Human Services is seeking proposals to open three four-bedroom homes to serve individuals with intellectual and/or developmental disabilities experiencing significant behavioral challenges that make it temporarily unsafe to live at home.

The \$4 million initiative seeks to create short-term placements in home-like environments staffed with professionals trained in supporting individuals with IDD who are experiencing significant behaviors or behavior crises.

The program will not replace in-patient hospitalization when medically indicated, but will help prevent hospitalization for some individuals and will help provide a hospital discharge option to a safe and professional environment for others.

During the short-term stay, trained professionals will assess individuals and implement new behavior management techniques so they may return home safely.

“Through this program, we are creating a short-term, highly structured, nurturing housing environment complete with professional assistance to help individuals get through or prevent a behavioral crisis so they can get back home safely and successfully,” Acting Commissioner Adelman said.

“The intent is to stabilize crises while diagnostic assessments, services, and supports that meet the individual’s needs are provided,” said Assistant Commissioner Jonathan Seifried, who directs the DDD.

The submission deadline for providers is July 2, and Human Services expects to make a final award in September.

Governor's Budget Proposes \$4M for Scholarships to Provide More Psychiatrists in New Jersey

The Murphy Administration aims to expand access to in-demand psychiatric services by increasing the supply of trained professionals in the field.

The Governor's proposed budget calls for \$4 million to fund 10 four-year psychiatric residencies. In exchange, the residency programs will ensure these physicians will have rotations in a range of publicly funded and community-based mental health settings during their residencies. The initiative will focus on the treatment of lower income individuals, especially those with serious mental illness and those co-occurring mental health substance use disorders.

"There has been a need for more psychiatrists for years, and now the need is even greater," Acting Commissioner Adelman said. "Professional help is often the key to recovery for people with emotional and behavioral health issues. We have to invest in the pipeline so the help is available for people who need it."

"We can't underestimate the emotional impact of COVID, especially on people who are already struggling," Assistant Commissioner Valerie Mielke said. "The worry, uncertainty, and personal and

financial losses can seem overwhelming.”
