## **2019 Annual Report on Access to Employer-Based Health Insurance**

### **Background**

In August 2006, legislation was enacted (P.L. 2006, c.87) directing the Commissioner of New Jersey's Department of Human Services (DHS) to prepare an annual report on Access to Employer-Based Health Insurance for Medicaid enrollees.

The purpose of this report is to identify employers in the State who employ an aggregate of 50 or more employees enrolled in NJ FamilyCare, the State's Medicaid and CHIP program.

### **Data Sources**

Data sources include The New Jersey Department of Labor and Workforce Development's (LWD) Wage Reporting database and DHS' Division of Medical Assistance and Health Services Shared Data Warehouse. It is important to note that there are limitations inherent to the information available for this report. The LWD file does not contain the enrollee's quarterly income or number of hours worked. As a result, full-time or part-time status, and duration of employment with a particular employer cannot be discerned. The data within this report sourced from LWD and DMAHS represents the third quarter of 2019, July 1, 2019 to September 30, 2019. A quarterly data sample was chosen because it is a sufficiently large data set to be representative.

Although the enabling legislation calls for the employer's address or work site, the data source utilized does not list individual employment sites. Instead the data file provides an address directly related to each tax identification number which may be a corporate site or a payroll vendor.

### **NJ FamilyCare**

NJ FamilyCare is the single program for public medical assistance in the state. Included are Medicaid, Title XIX, and the Children's Health Insurance Program (CHIP), Title XXI. NJ FamilyCare provides health coverage to children, pregnant women, parents/caretaker relatives, single adults, childless couples, the aged, blind, disabled, and individuals qualified for long-term care services. Beneficiaries receive free or low cost health coverage including: doctor visits, hospital services, prescriptions, tests, vision care, mental health care, dental, nursing home care and other healthcare services, depending on the person's eligibility category.

Funding is derived from both State and Federal sources. Through the Affordable Care Act, New Jersey expanded program eligibility to individuals with household incomes at or

below 138% of the Federal Poverty Level (FPL) (\$17,237 for a household size of one). This adult group can be eligible for NJ FamilyCare coverage and have other insurance.

Under the CHIP program, children in families with higher household incomes, between 147% and 355% of the Federal Poverty Level or between \$37,853 and \$91,413 per year for a family of four, can be eligible for NJ FamilyCare. In most cases, an enrollee must have been uninsured for three months before they are eligible for NJ FamilyCare. There are exceptions to this policy, such as a family losing health insurance through no fault of their own, i.e., parent was laid off.

## **Report Summary**

894 private sector employers in NJ employing 50 or more NJ FamilyCare beneficiaries were identified. Collectively, these companies employed 171,596 people (see Column A of Appendix A) who received health care coverage through NJ FamilyCare. In addition, 258,044 dependents (see Column B of Appendix A) of these employees were covered by NJ FamilyCare.

This report also includes data regarding government agencies in New Jersey employing 50 or more NJ FamilyCare beneficiaries. 70 government agencies employed 8,803 people (see Column A of Appendix B) who received health care coverage through NJ FamilyCare. In addition, 13,201 dependents (see Column B of Appendix B) of these employees were covered by NJ FamilyCare.

In cases where an NJ FamilyCare beneficiary funded under Title XIX Medicaid has private insurance, Medicaid becomes the payer of last resort. NJ FamilyCare's reimbursement is subsequent to payments made through private coverage for allowable medical services. 30,516 private sector employees and 1,895 government sector employees had private insurance (see Column F) in addition to NJ FamilyCare coverage.

New Jersey's WorkAbility Program offers complete NJ FamilyCare coverage to working people with disabilities whose earnings would otherwise make them ineligible for program enrollment. Generally to be eligible for NJ Workability, a person must be between the ages of 16 and 64, working part-time, full-time or be self-employed, have a permanent disability and meet certain income and resource guidelines. 2,545 employees working in the private sector, and 164 working for government agencies receive NJ FamilyCare benefits through NJ Workability (refer to column D in the Appendices)

## **Federal and State Costs**

Funding of NJ FamilyCare is shared by Federal and New Jersey State governments. Percentages vary according to eligibility group. For the third quarter in 2019, Title XIX Medicaid federal share ranged from 50% to 93%. Title XXI CHIP federal share was 88%. Jointly funded expenditures totaled \$418.1 million over the three month reporting period.

This includes NJ FamilyCare beneficiaries employed by private sector employers at a cost of \$396.3 million, and government agencies at a cost of \$21.8 million. Of the jointly funded total, spending for Title XIX Medicaid was \$398.9 million and \$18.1 million for Title XXI CHIP. The remaining \$1.1 million went to programs funded through State-only dollars.

New Jersey's portion of the expense for NJ FamilyCare beneficiaries employed by the private sector and government agencies was \$116.5 million with breakdown as follows: Title XIX Medicaid \$113.14 million, Title XXI SCHIP \$2.24 million and \$1.11 million for state-only funds.

- The Department of Labor file does not contain enrollee quarterly income or number of hours worked.
- Working NJFC Recipients may have more than 1 employer.

### **Charity Care Information Submitted by the Department of Health**

The statute requires the Department of Health (DOH) to compile, to the extent data are available, information about employed recipients of Charity Care. Specifically, the law requests the following information: the employer's name and address, the number of recipients on Charity Care who are employed by the employer; and the cost to the State of providing Charity Care for employer's employees and their dependents. The DOH has reviewed the data submission process and supporting information technology structure and determined that this data is not available. In addition, DOH as required by the "Charity Care Fraud Prevention and Detection Act," has reviewed, with the Division of

Taxation, the potential for file matching to ascertain the employer and wage data for Charity Care recipients. The results of the review indicated that the lack of a consistent identification number, such as social security number, makes the desired analysis infeasible.
