

NOTICE OF FUNDING AVAILABILITY

Designated Screening Services Essex and Warren County

TAKE NOTICE that, in compliance with N.J.S.A. 52:14-34.4, 34.5 and 34.6, the Division of Mental Health and Addiction Services (DMHAS) hereby announces the availability of the grant program funds described herein.

Program Name: Designated Screening Services Essex and Warren Counties

Purpose: The Division of Mental Health and Addiction Services (DMHAS) anticipates making (two/three) awards for Essex County and one award for Warren County through this RFP that will result in continued provision of Designated Screening Services (i.e. Psychiatric Emergency Services) in Essex and Warren Counties. The psychiatric emergency service programs awarded through this RFP will offer services to individuals who may be approaching or are experiencing a psychiatric crisis. Prompt assessment, crisis intervention and referral services will be offered 24 hours per day, 365 days per year. The program will also operate a 24 hour hotline, with calls being answered by trained clinical staff at all times.

Available Funding Amount: Annualized funding from the DMHAS, subject to state appropriations, is available as follows:

Essex County – Western Essex Service Area: \$1,661,883
Essex County – Central Essex Service Area: \$1,057,043
Essex County – Southeastern Essex Service Area \$1,753,397

Warren County - \$958,855

Who Can Apply/Bidder Qualifications:

To be eligible for consideration for this RFP, the bidder must satisfy the following requirements:

- The bidder may be a non-profit, for-profit or governmental entity;
- For a bidder that has a contract with DMHAS in place when this RFP is issued, that bidder must have all outstanding Plans of Correction (PoC) for deficiencies submitted to DMHAS for approval prior to submission;
- The bidder must be fiscally viable based upon an assessment of the bidder's audited financial statements. If a bidder is determined, in DMHAS' sole discretion, to be insolvent or to present insolvency within the twelve (12) months after bid submission, DMHAS will deem the proposal ineligible for contract award;


- The bidder must not appear on the State of New Jersey Consolidated Debarment Report at <http://www.state.nj.us/treasury/revenue/debarment/debsearch.shtml> or be suspended or debarred by any other State or Federal entity from receiving funds;
- The bidder shall not employ a member of the Board of Directors in a consultant capacity;
- The bidder must attend the Mandatory Bidders conference as described in the RFP.
