##### **CHAPTER HISTORICAL NOTE:**

Chapter 87, Pediatric Medical Day Care Services, was adopted as new rules by R.2009 d.346, effective November 16, 2009 (operative April 1, 2010). See: [40 N.J.R. 6328\(a\)](#), [41 N.J.R. 4257\(a\)](#).

Chapter 87 of Title 8, Pediatric Medical Day Care Services, was recodified as Chapter 166 of Title 10 by administrative change, effective June 16, 2014. As a part of the recodification, administrative changes were made throughout concerning cross-references, agency names and addresses, and the elimination of text rendered redundant or moot by the transfer of authority.
