**Summary** of Public Comment and Agency Response:

No comments were received from the public.

#### Federal Standards Statement

A Federal standards analysis is not required because the rules readopted with amendments comply with, but do not exceed, applicable Federal requirements or standards in the Health Information Portability and Accessibility Act, 45 CFR 160.103.

# **Summary** of Agency-Initiated Changes:

- In the amended definition of "Level I standards," the Department of Human Services (DHS) intended to correct the cross-reference in N.J.A.C. 10:37-2.5 to N.J.A.C. 10:37J-2.5. Due to a publication error, this correction did not get into the proposal and it is being corrected upon adoption.
- At N.J.A.C. 10:37J-2.3(b)3, DHS is updating the reference from DSM IV to DSM 5 as that is the most current edition. Reference to Axis 1 is deleted as DSM 5 no longer references Axis 1.
- 3. As a result of the amended definition of "Level I standards," N.J.A.C. 10:37J-2.4(c) is no longer identified as a Level I Standard. Therefore, the cross-reference in N.J.A.C. 10:37J-2.4(a) must state that all standards except subsection (c) relating to program intensity are considered Level I standards. Program intensity is not considered a Level I standard; Level I standards pertain to staff qualifications, consumer safety and rights.
- 4. DHS is amending N.J.A.C. 10:37J-2.7(e) for clarity. A Programs of Assertive Community Treatment program may discharge or terminate a consumer according to standards stated at N.J.A.C. 10:37J-2.7(c) or (d). Referencing N.J.A.C. 10:37J-2.7(d)4 is redundant as paragraph (d)4 is included in subsection (d). The language is misleading as a consumer cannot be discharged and terminated at the same time.

## 10:37J-1.2 Definitions

The following words and terms, as used in this chapter, shall have the following meanings, unless the context clearly indicates otherwise.

...

"Level I standards" means those standards with which mental health programs must be in full compliance in order to be granted or to continue to receive a full Department license. Level I standards include those standards that relate most directly to consumer rights, safety, and staffing. With specific reference to the PACT program, Level I standards are: all standards in N.J.A.C. 10:37J-2.4, Program intensity except subsection (c); N.J.A.C. \*[10:37]\*\*10:37J\*-2.5(c), (d)1, (e), (h), and (l) services to be provided and service coordination; and N.J.A.C. 10:37J-2.8(a), (b), (c) (except for paragraphs (c)1 through 8), (d), and (i), staff requirements.

10:37J-2.3 Eligibility
