The New Jersey Care. . . Special Medicaid Programs Manual extends Medicaid eligibility to certain persons not eligible under the provisions at N.J.A.C. 10:69, AFDC-Related Medicaid, or 10:71, Medicaid Only. The Department of Human Services (Department) recognizes that further rulemaking is necessary to update these rules to address ongoing changes to the program. To that end, the Department is preparing a notice of proposal with substantive amendments to this chapter to be published following this readoption, which is intended to prevent the chapter from expiring.

The Department has reviewed the rules and has determined them to be necessary, reasonable, and proper for the purpose for which they were originally promulgated. Therefore, pursuant to N.J.S.A. 30:4D-1 et seq., and 30:4J-8 et seq., and, in accordance with N.J.S.A. 52:14B-5.1.c(1), these rules are readopted and shall continue in effect for a seven-year period.

The rules establish the policies necessary for the orderly and equitable provision of the Work First New Jersey program, which provides financial and other assistance to low income adults and families throughout New

Jersey. The Department of Human Services (Department) recognizes that further rulemaking may be necessary to implement changes in policy and State or Federal law. Further, the Department intends to review its emergency measures implemented during the COVID-19 public health emergency to determine if any of these measures should be incorporated into Chapter 90. The Department may propose substantive amendments to this rule following this readoption.

The Department has reviewed the rules and has determined them to be necessary, reasonable, and proper for the purpose for which they were promulgated. Therefore, pursuant to N.J.S.A. 30:1-12 and, in accordance with N.J.S.A. 52:14B-5.1.c(1), these rules are readopted and shall continue in effect for a seven-year period from the date of filing of this notice.

The Department of Human Services has determined that the chapter remains necessary, proper, reasonable, efficient, understandable, and responsive to the purposes for which it was originally promulgated, as amended and supplemented over time, and should be readopted without amendment.
