Under the direction of a manager in a state department, provides a wide range of administrative services in support of a Chief within the area of assignment; assists in the coordination of management/administrative activities of an assigned unit or work area. Assists other office staff with the following: PEOSH Hotline; checking E-UPA Inbox; issuing Correspondence (order to comply, extension-related letters, hazard awareness letter); monitor PEOSH Webmail Inbox; order office supplies and personal protective equipment (PPE); answer Telephone using Office Desk Phone / Avaya Phone Application; complete Ethics Outside Activity Forms; complete Training and Travel Requests; PEOSH Dashboard Maintenance; appropriate Routing of Correspondence for Review (PSOSH Review Group); maintain Inventory of PEOSH Equipment / Supplies; maintain / Update Office Schedules / Staff Contact Information / Vehicle Assignments; run Various Reports from Databases and Provide Summary Reports (Monthly Metrics Report); assemble Weekly Report to Division; work with Chief to Maintain List of Pending Items; transmit Appeal Package to the Office of Administrative Law concerning Whistleblower Cases; work with Procurement / Accounting and Finance (travel Reimbursements, Subscription Services [NFPA and ASSP], OSHA One Time Funding, Eye Exam / Eye Glass Related Reimbursements as applicable, Answering Service, Follow up on / track requests); Scheduling Informal Conferences / Contests, Communicate with Staff for Holiday Coverage; interviews for New Staff; maintain Records (Workers Memorial Day; make requests for, and monitor, records from Archives / Storage upon request; monetary Penalties; settlement Agreement Status / Progress; personnel as needed); State Plan (Memorandum of Understanding (DOL/DOH); adoptions of Rules / NJ Register (Legal); coordinate Preparation of Annual Grassroots Report); maintain Dates of Upcoming Meetings for Advisory Board and NJSISC); fills in for above listed duties as needed when Senior Clerk Typist office staff is out; other duties as required.

REQUIREMENTS:

NOTE: Applicants must meet one of the following or combination of both experience and education. Thirty (30) semester hour credits are equal to one (1) year of relevant experience.

Five (5) years of professional experience performing complex administrative support work which must have included the interpretation, verification and/or application of department/agency rules, regulations, policies and procedures.

OR

Possession of a Bachelor's degree from an accredited college or university; and one (1) year of the above-mentioned professional experience.

NOTE: "Professional experience" refers to work that is analytical, evaluative, and interpretive; requires a range of basic knowledge of the profession's concepts and practices; and is performed with the authority to act and make accurate and informed decisions.

RESUME NOTE: Eligibility determinations will be based only upon information presented on the resume along with other supporting documents. Applicants who possess a degree from a college or university outside the United States must provide an evaluation of the transcripts from a recognized evaluation service at the time of submission. Failure to do so may result in your ineligibility.

LICENSE: Appointees will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform the essential duties of the position.

Consensual personal relationship means marriage, engagement, dating or other ongoing romantic or sexual relationships.

Cohabitant means non-related persons who share a household under circumstances where there is financial interdependence.

The New Jersey Department of Labor and Workforce Development requires the disclosure of all relatives and consensual personal relationships to be promptly reported directly to the Division of Human Capital Strategies (HCS), Director’s Office. Confidentiality shall be maintained to the extent possible and practicable. This information may be shared with NJ DOL’s Equal Employment Opportunity Office and/or the NJ DOL Ethics Office as deemed necessary. Upon receiving notice of the relationship, HCS may address any situation as necessary in consultation with the EEO Office and/or the Ethics Officer. This may include, but is not limited to, the changing of reporting relationships or transferring any of the employees involved. Failure to provide notification to HCS may result in discipline up to and including termination and the denial of legal representation and indemnification by the State in the event that a lawsuit is filed having a connection with a personal relationship. Employees are under a continuing obligation to promptly report personal relationships that develop during the course of their employment.
