In March 2019, T.H.E. Technologies, LLC ceased to operate at 310 Main Street, Suite 7B, Toms River, New Jersey 08753.

Currently, the Center for Occupational Employment Information's Training Evaluation Unit is in the process of obtaining information from the school's owner as well as students enrolled at the time of the school's closure.

While this is an understandably trying time for all students affected by this closure, the Training Evaluation Unit is asking for your patience. Once all alternatives have been reviewed, you will be provided an explanation of your options. In the meantime, it is imperative that you contact your lending institution, if applicable, to notify it of the school's closure.

The Training Evaluation Unit is requesting that all students enrolled and attending T.H.E. Technologies in March 2019, forward the following information by **April 12, 2019**:

- Name, address, phone number and email address;
- Program name, start date and last date of attendance;
- Enrollment status (in class; waiting for externship; attending externship; graduated; etc.)
- Copy of signed Enrollment Agreement (contract) with T.H.E. Technologies;
- Receipts for any out-of-pocket tuition payments to T.H.E. Technologies;
- Cancelled checks payable to T.H.E. Technologies for tuition;
- Credit card receipts for tuition payments to T.H.E. Technologies; and,
- Copies of loan agreements/disbursements for student loans, if applicable.
