2020 Census


- Mandated by Article 1, Section 2 of the U.S. Constitution
- Conducted every 10 years ending in zero since 1790
- Counts every resident in the United States where they live and sleep most of the time
- Increasingly diverse and growing population
 - 330 million people
 - Over 140 million housing units
- Confidential
 - Responses are protected by Federal Law
 - Responses are only used to produce statistics

Uses of Census Information

- Determines the number of seats each state has in the U.S. House of Representatives
- Defines congressional and state legislative districts, school districts and voting precincts
- Determines how more than \$675 billion dollars in federal funding are spent on infrastructure, programs and services each year
- Informs government, business and community planning and decisions
- Provides business and nonprofit organization with critical information for planning decisions
- Provides population benchmarks for nearly every other United
 States survey









2020 Census: Where Are We Today?

Complete Count Committee

 A Complete Count Committee (CCC) is a committee that can be established by tribal, state and local governments, community leaders, or organizations to increase awareness of the 2020 Census messaging of the employment opportunities and motivate households to respond to the 2020 Census

Advantages of a Complete Count Committee

- The CCC speaks the language of and knows the pulse of its community, therefore establishing an information highway that even the internet cannot rival—neighbor informing neighbor.
- The CCC gains valuable knowledge about the census process at the local level and develops a plan to impart that knowledge to each and every household as only a neighbor and fellow stakeholder can do.
- The CCC increases participation and the response rate by increasing awareness of the 2020 Census through October of 2020.


Complete Count Committee Goals
