

GUÍA DE 8 PASOS PARA OBTENER EL 1099-G



NECESITARÁ UNA COPIA DE SU FORMULARIO 1099-G PARA DECLARAR SUS IMPUESTOS FEDERALES SOBRE LA RENTA

Aunque el estado de New Jersey no grava los beneficios del Seguro de Desempleo, estos se consideran ingresos y están sujetos a impuestos federales sobre la renta. La cantidad de beneficios que recibe en un año calendario se le informa en un formulario 1099-G.


