A-7 MOTION TO SUPERIOR COURT BY THE BOARD OF REVIEW TO REMAND THE FOLLOWING DECISION(S) FOR RECONSIDERATION

Claimant appealed to Superior Court from a decision of the Board of Review which affirmed the decision of the Appeal Tribunal dismissing the appeal as the appellant failed to file within the statutory period. Superior Court stayed proceedings under R. 2:5-5(a) to settle the record. Board of Review would request a remand from Superior Court for supplementation of the record under R. 2:5-5(b).

ACTION: BOARD VOTED TO ACCEPT THE ABOVE CASE AS A MOTION TO SUPERIOR COURT BY THE BOARD OF REVIEW TO REMAND THE DECISION FOR THE BOARD'S RECONSIDERATION.
