#### **A-1 VACATED APPEALS BY THE BOARD OF REVIEW**

**1. BOR DKT. 00366985 (J.S.)**

Claimant's communication was processed as an appeal of the decision of the Appeal Tribunal which held the claimant not unemployed and a liability for a non-fraud refund.
