NO MORE THAN 24 HOURS, INCLUDING REHEARSAL IN A WEEK. NOT BEFORE 7 A.M. OR AFTER 11:30 P.M., EXCEPT WITH THE PERMISSION OF THE COMMISSIONER OF LABOR. COMBINED SCHOOL AND THEATRICAL PERFORMANCE TIME SHALL NOT EXCEED 8 HOURS A DAY. MINOR WILL BE AT ALL TIMES UNDER THE SUPERVISION OF THE ADULT NAMED ON THE REVERSE WHO IS THE PARENT, GUARDIAN OR EMPLOYEE REPRESENTATIVE. IF THE MINOR IS NOT ATTENDING PUBLIC SCHOOL AND A PERIOD OTHER THAN DURING SUMMER VACATION IS REQUESTED, THE MINOR SHALL RECEIVE EQUIVALENT INSTRUCTION APPROVED BY THE DEPARTMENT OF EDUCATION OR BY THE STATE OR COUNTY OF RESIDENCE, IF A NON-RESIDENT OF NEW JERSEY.
