### DGE Announces November 2019 Total Gaming Revenue Results

#### Industry:

Based upon filings with the Division of Gaming Enforcement, Total Gaming Revenue for November was \$306.0 million compared to \$257.4 million in November 2018, reflecting an 18.9% increase. Casino Win for November was \$224.0 million increasing 7.1% from the same month last year. Internet Gaming Win was \$49.1 million in November compared to \$26.9 million in the prior period, reflecting an increase of 82.4%. Sports Wagering Gross Revenue was \$32.9 million for the month, compared to \$21.2 million for the same month last year, reflecting a 54.8% increase.

For the year-to-date, the Industry's Total Gaming Revenue was \$3.181 billion through November 2019 compared to \$2.645 billion in the prior period, reflecting an increase of 20.3%. Casino Win was \$2.478 billion reflecting a 7.7% increase over the prior period. Internet Gaming Win increased 60.7% to \$433.4 million when compared to the prior period. Sports Wagering Gross Revenue was \$270.0 million.

#### Tax Information:

For the month of November 2019, total gaming taxes were \$27.4 million. Total gaming taxes reflect 8% of taxable casino gross revenue, 15% of Internet gaming gross revenue, 8.5% tax on casino and racetrack sports wagering gross revenue and 13% tax on casino and racetrack sports wagering Internet gross revenue. In addition, the casino industry incurred \$4.2 million in 1.25% Additional Tax on sports wagering gross revenue and Investment Alternative Tax Obligations (which reflects 1.25% of casino gross revenue and 2.5% of Internet gaming gross revenue). For the month of November 2019, the Racetrack Economic Development Tax of 1.25% of racetrack sports wagering gross revenue was \$217,326.
