#### RA MANDATORY TIMEFRAMES

The Remedial Action (RA) mandatory timeframes for legacy contaminated sites that received the Remedial Investigation (RI) mandatory timeframe extension in May 2014 are fast approaching (May 2024). If you, as the retained LSRP, do not think that the Person Responsible for Conducting the Remediation (PRCR) will have the RA completed by then (i.e., RAO issued) you are REQUIRED TO NOTIFY IN WRITING the PRCR and Department before the deadline. ## TECHNICAL REVIEW PANEL RE-ESTABLISHED

NJDEP Contaminated Site Remediation and Redevelopment (CSRR) has announced that it has re-established the Technical Review Panel (TRP) to address technical disagreements between LSRPs and CSRR staff. The goal of the TRP process is to resolve these disputes as quickly as possible to ensure that the remediation of sites results in the protection of public health and safety and the environment and occurs in an expeditious manner.
