**FREQUENTLY ASKED QUESTIONS (FAQs)**

Persons interested in applying to become a Licensed Site Remediation Professional (LSRP) may obtain the LSRP Licensure Application Form and Application Form Instructions from the Site Remediation Professional Licensing (SRPL) Board website at [www.nj.gov/srpboard](http://www.nj.gov/srpboard).

The Application Form Instructions should be read in their entirety prior to completing the Application Form. Most questions will be answered by the Application Form Instructions. Additional questions are addressed below.

**FAQ: What are the steps to becoming an LSRP?**

To become an LSRP, an individual must submit an application that demonstrates that he or she meets all the eligibility requirements. An individual whose application is approved by the Board must then take and obtain a passing score on the LSRP examination. The Board is currently administering the LSRP examination approximately once every 18 months.

**FAQ: When can I submit an application?**

The Board accepts applications beginning approximately four months prior to the next scheduled LSRP examination. The Board posts the dates that applications will be accepted on the Board website at [www.nj.gov/srpboard](http://www.nj.gov/srpboard). **FAQ: What are the fees for the application and examination?**

The application fee for the 2022 LSRP examination is \$300. No application will be reviewed unless accompanied by the application fee. The application fee also covers the LSRP examination. To be issued a license, an individual that obtains a passing score on the LSRP examination must first pay the annual license fee.

**FAQ: What are the eligibility requirements?**

Each applicant for a license shall demonstrate to the Board that he or she:

1. Holds a bachelor's degree or higher in natural, chemical, or physical science or an engineering degree in a discipline related to site remediation, from an accredited institution of

higher education.

2. Has at least eight years of full-time professional experience in the field of site remediation, of which at least five years shall have occurred in New Jersey and at least three years shall have occurred in New Jersey within the five years prior to submission of the application.

3. Has a minimum of 5,000 hours of relevant professional experience within New Jersey over the five years immediately prior to submission of the application that is of a professional grade and character that indicates the applicant is competent to issue a response action outcome.

4. Has attended and completed the minimum environmental health and safety education and training, provided pursuant to 29 C.F.R. Section 1910.120, no more than one year prior to submission of the application.

5. Has completed a Board-approved course on the State's rules and regulations concerning the technical requirements for site remediation no more than three years prior to submission of the application.

6. Has not been convicted of, or pled guilty to, an environmental crime, any similar or related crime under Federal or state law, or any crime involving fraud, breach of trust, theft by deception, forgery, or any crime or offense that would qualify the person for registration pursuant to section 2 of P.L.1994, c.133 (C.2C:7-2), or any other crime involving moral turpitude, or any similar or related offense under Federal or state law. For the purposes of this section, a conviction or plea of guilty shall include a non vult, nolo contendere, no contest, or finding of guilt by a judge or jury; and

7. Has not had a professional license or professional certification revoked by any state licensing board or any other professional licensing agency within the previous 10 years and has not surrendered a professional license or professional certification in response to a disciplinary investigation within the previous 10 years.

**FAQ: What is “full-time professional experience”?**

“Full-time professional experience” means experience in which an applicant is required to apply scientific or engineering principles to contaminated site remediation where the resulting conclusions form the basis for reports, studies or other documents connected with the remediation of a contaminated site. The Board may consider the applicant's work activities, field of practice, duration of employment, and work products prepared in determining the credit to be allowed for professional experience. The Board may allow applicants with relevant advanced degrees up to two years of credit for professional experience, of which one year of credit may

be awarded for applicants who have earned a master's degree in a relevant field of study and up to two years of credit may be awarded for applicants who have earned a doctorate degree in a relevant field of study.

**FAQ: What is “relevant professional experience”?**

“Relevant professional experience” means experience working on New Jersey remediation cases. To prove relevant professional experience, the applicant must demonstrate that he or she has:

(a) Knowledge of and experience with implementing the technical, scientific, and regulatory aspects of site remediation, including experience investigating, designing, and implementing and/or managing within each phase of the site remediation process:

1. Preliminary Assessment
2. Site Investigation
3. Remedial Investigation and
4. Remedial Action

(b) Produced, or participated in producing, workplans and/or reports for each phase of the site remediation process; and

(c) Knowledge of and experience with meeting the Department’s administrative requirements, including but not limited to, requirements pertaining to submittal of forms, regulatory and mandatory timeframes, applicable fees, presumptive remedies, remedial action permits and public notification.

**FAQ: How many hours per week must I work to be considered “full-time”?**

In order to claim full-time professional experience, the applicant must have worked at the firm an average of at least 40 hours/week, with an average of at least 20 hours/week devoted to the application of scientific or engineering principles to contaminated site remediation where the resulting conclusions form the basis for reports, studies or other documents connected with the remediation of a contaminated site.

**FAQ: Do I have to provide time sheets with my application to document my hours?**

You do not need to provide timesheets but may estimate your hours using a reasonable methodology.

**FAQ: What are the Board-approved courses on the State's rules and regulations concerning the technical requirements for site remediation?**

*“Case Study Training for LSRPs – the Next Generation”* (2019-098). The course completion dates for valid Board credit during this LSRP Exam application period are November 17 and 18, 2021, and October 24, 2019.

**FAQ: How can I find out the status of my application?**

The Board will notify an applicant of its decision to approve or deny an application no later than 60 days after the Board receives a complete application or additional information, if required.

**FAQ: What is the process to register for the examination?**

When the Board approves an application, the Board will notify the applicant that he or she is a candidate for the LSRP examination. The notification will include information concerning registration for the next scheduled LSRP examination.

The notification will also include an LSRP Examination Candidate Agreement, which will include the rules concerning the examination. No person will be permitted to take the examination unless he or she signs a statement certifying that he or she has read the LSRP Examination Candidate Agreement and agrees to abide by its terms.

**FAQ: How can I prepare for the examination?**

**FAQ: I have a disability covered under the Americans with Disabilities Act; will I be accommodated?**

If you indicate that you have a disability on the Licensure Application Form accommodations will be made for you at the examination.
