Of the 146 licenses expiring in October, 142 LSRPs submitted applications which were all approved for renewal, and 4 LSRPs did not submit applications for license renewal, so their licenses will expire in October.

The Board received 77 applications for the October 17, 2018 licensing exam. Of those 77 applications, 74 complete applications were received by the July 15 deadline so were reviewed by Department staff. Of those 74 applications, one was not approved, so 73 applicants are eligible to take the exam.
