# CFC campaign kicks off; looking for federal employee participation

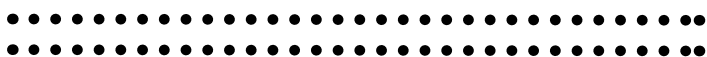

## DMAVA Green

The Defense Department's current reliance on expensive, difficult-to-transport and finite fossil fuels affects cost-reduction efforts as well as war-fighting operations, a senior Pentagon official said.

"Certainly, for current operations and for the future, one of the things we're really focused on is reducing demand, [which is] reducing our consumption, because no matter what kind of energy we're using, the amount of energy we're using causes us problems in practice -- particularly in the kinds of fights we're fighting today where so much of our logistics train is in the battlefield," Sharon Burke, director of the department's operational energy plans and programs, said in a recent "DoDLive" Bloggers roundtable.

In her recently created position, Burke's job, she said, is to look into current operational energy usage and find ways to lower total fossil fuel consumption, and to work toward incorporating alternative and renewable energy sources into the fighting force.

As military installations have worked to become more "green" over the past few years by incorporating alternative power sources and electric vehicles, Burke said, the conflicts in Iraq and Afghanistan have renewed interest in reducing fossil fuel usage for military operations.

The first order of business, she said, is curbing the demand for fossil-based fuels. At a recent DOD-sponsored energy forum, Mullen described the "old" military mentality when it came to fuel as "burn it if you got it." Burke said that mentality has to be changed before any real operational reform can happen.

For example, Burke said, use of biofuel-blended JP-8 jet fuel will be part of the solution because of its prevalence in war zones. However, she added, the solution is wider ranging.

"Whether we're putting it [jet or diesel fuel] in generators to turn it into electricity to power computers and communications gear, or whether we're putting it into vehicles, almost all the fuel we use on the battlefield is petroleum-based," she said. "So we have to focus on it. But no matter what kind of energy it is, we have to find a way to use less."

Burke said a big part of her office's role is to seek innovative ideas for battlefield-ready products. Marine Corps units, she said, have started deploying with solar-powered generators. Meanwhile, she added, the Army is implementing use of better-insulated tents and water-recycling technology to save energy, and the Air Force has worked for many years to incorporate alternative and renewable fuel sources into their operations.

Burke said she wants to ensure the services don't lose any vital tools as they pare down fuel consumption. It's important to get usage levels -- and therefore, costs -- down, she said, but not as important as providing enhanced capability to troops in the field, which new energy technology can do.

## Holiday mailing dates given for overseas packages, cards

For those mailing packages to friends and loved ones in the military overseas, Christmas comes early. And Hanukkah comes even earlier.

It depends on how you plan to send it, but if it’s traveling the slowest way — parcel post — mail that package by Nov. 12 to get it there by Dec. 25, according to recommended holiday shipping dates provided by the Military Postal Service Agency.

Here are the other recommended mail deadlines. Subtract 24 days from each deadline to get it there in time for Hanukkah:

- Space Available Mail (SAM): Nov. 20 to contingency locations (APO/FPO/DPO AE Zip 093); all other overseas military locations by Nov. 26.
- Parcel Airlift Mail (PAL): Dec. 1 to contingency locations; all others by Dec. 3.
- Priority Mail: Dec. 4 to contingency locations; all others by Dec. 10.
- First-class cards and letters: Dec. 4 to contingency locations; all others by Dec. 10
- Express Mail Military Services: Not available to contingency locations; other locations by Dec. 18. Check with your local post office to determine if this service is available to a particular APO/FPO/DPO address.

## *VA takes life-saving line to streets of Philadelphia*

Beginning Monday, the Department of Veterans Affairs began advertising the Suicide Prevention Lifeline on Philadelphia’s SEPTA mass transit. The effort includes 140 SEPTA buses, 48 bus shelters, 97 subway interior posters, and 110 rail/subway station posters with a message of hope for those who have served their country and find themselves in an emotional crisis.

“It’s exciting to have this resource come to Philadelphia,” said Dr. Dave Oslin, the Philadelphia VA Medical Center Interim Chief of Staff. “It highlights an important program for a Veteran or loved one who may need a place to turn for help. And that help is available if they will just call.”

Dr. Oslin adds that it is especially important for family or friends to notice the warning signs of suicide and to provide the Lifeline number to their loved one. These signs can include talking about death, displaying uncontrolled rage or anger, and trying to get guns, pills or other means to harm oneself.

Since its inception in July 2007, VA’s Suicide Prevention Hotline, 1-800-273-TALK (8255), has rescued more than 10,000 Veterans and provided counseling for more than 180,000 Veterans and their loved ones at home and overseas. The hotline is staffed 24 hours a day, seven days a week by trained mental health professionals prepared to deal with immediate crises. The hotline also offers an anonymous online chat feature available at [www.suicidepreventionhotline.org](http://www.suicidepreventionhotline.org). Look for the chat feature in the upper right hand box.

VA has publicized the hotline through mass transit campaigns since summer of 2008, increasing the number of calls and lives saved with each city the campaign has reached. VA is partnering with Blue Line Media ([www.BlueLineMedia.com](http://www.BlueLineMedia.com)), a transit advertising company, for the campaign. The SEPTA advertisements continue until Jan. 9, 2011.

VA has also promoted awareness of the hotline through national public service announcements featuring actor Gary Sinise and broadcast journalist Deborah Norville. The transit advertisements and both PSAs are available for download via YouTube and at [www.mentalhealth.va.gov/suicide\\_prevention](http://www.mentalhealth.va.gov/suicide_prevention).

## Government benefits must be through EFTs for all

Prepare for the change. Americans who enroll for federal benefits on or around March 1, 2011 will have to choose Direct Deposit or Direct Express Debit MasterCard. The Direct Express debit card is used when the applicant does not have a bank account.

It costs the federal government \$1.03 to issue a check but only 10.5 cents to issue an electronic fund transfer. Putting all government payments into EFTs will save the government about \$400 million dollars and about 12 million pounds of paper.

By 2013, the recipients of the more than 136 million benefit checks that the federal government mails out each year will have no choice but to be on the EFT program.

## October is open enrollment for state employees

### Open enrollment for 2011 – state health benefits and tax savings programs

October is the State Health Benefits Program and State Employees Tax Savings Program open enrollment period — your annual opportunity to review SHBP and Tax\$ave coverage and make any changes for you and/or your dependents for the 2011 plan year. During the Open Enrollment you may:

- Enroll in SHBP plans if you have not previously done so, change to a different SHBP medical plan and/or dental plan, and add eligible dependents – including children up to age 26\* under federal health care reform changes – see the *Health Capsule* newsletter for details.
- Enroll, or renew enrollment, in Tax\$ave Flexible Spending Account plans for the coming plan year.\*\* See the *Tax\$ave News* for new reimbursement limits on over-the-counter medications and eligibility of children up to the age of 26.

Starting this year, open enrollment publications are only available online. See the Health Capsule and Tax\$ave Newsletter and fliers for detailed open enrollment information. Go to: [www.state.nj.us/treasury/pensions/](http://www.state.nj.us/treasury/pensions/) and click the Open Enrollment links under “Special Announcements:”

- To change or enroll in SHBP plans, contact your human resources representative or benefits administrator to obtain an application. Medical and prescription drug coverage changes are made on the same application. Dental coverage changes are made on a separate application.
- To change or enroll in Tax\$ave plans, see the information on the Tax\$ave Open Enrollment Web site.
- Changes made during this Open Enrollment will be effective on January 1, 2011 for all employees.

\*Optional coverage for dependent children until age 31 is available under the provisions of Chapter 375, P.L. 2005.

\*\*Re-enrollment is required each year for continued participation in a Tax\$ave FSA plan.

### State savings bond program ends

The U.S. Department of the Treasury is discontinuing the offering of paper U.S. savings bonds through payroll savings plans. This change is effective beginning in January 2011. Because of this change, the State of New Jersey will no longer withhold deductions from employees' paychecks after Pay Period 26, 2010. Any Bond Balance remaining at the end of this calendar year will be refunded to you in a separate check.

While U.S. Savings bonds will no longer be available to you through payroll deductions from the State of New Jersey, you will still have the opportunity to continue to save automatically by using the Treasury Direct online system – a free online system that allows you to purchase, manage, and redeem electronic (paperless) savings bonds. ## *Fowler goes to Washington for honors from Vets History Project*

As National Guard Militia Museum of New Jersey Veterans Oral History Director, I was invited to the Library of Congress Veterans History Project (VHP) Tenth Anniversary Commemoration ceremony held in Washington, D.C., on Sept. 29.

The ceremony was held in the Jefferson Memorial, where James Billington, Librarian of Congress spoke. He noted that the Department of Defense will make the VHP an important part of next year's 50th Anniversary of the Vietnam War commemorations. He added that the program is, "by its very nature dependent on the continuing and growing enthusiasm and dedication of people like Carol Fowler from New Jersey and David Meyer O'Shea from California, who have performed hundreds of interviews and who are both here tonight."

Veterans History Project director, retired Col. Bob Patrick, introduced me to O'Shea. We agreed that the veteran interviewer was "an honored guest, going along for a journey," and swapped questions and techniques for the rest of the evening.

Subsequently I posed David O'Shea's favorite question, "tell me a story you never told anyone before" to a Vietnam veteran, who responded that his son discovered his name in a book that described an incident where he was surrounded and fought his way out. The veteran simply said, "I hadn't remembered it." It was truly a powerful moment!

## *TRICARE Reserve Select offers health insurance for "traditionalists"*

Membership in the National Guard has many benefits.

One perk often overlooked by traditional drilling Guard members is the ability to buy low-cost high-quality medical insurance for themselves and their families through the TRICARE Health Plan.

TRICARE Reserve Select membership allows for comprehensive health care coverage and access to a large number of doctors and hospitals as well as use of military treatment facilities. Coverage under TRICARE Reserve Select also includes eye exams, immunizations and health screenings, prescription drug coverage, behavioral health care and emergency treatment.

Premiums for TRICARE Reserve are substantially below market-rate premiums offered by private health insurance companies. Member coverage for TRICARE Reserve is \$46.92 per month and member-and-family coverage is \$197.65 per month. Annual outpatient deductibles are capped for members at the pay grade of E4 and below at \$50 for member-only coverage and \$100 for member and family coverage. The deductibles for E5 and above are \$150 for just members and \$300 for members covering family.
