## Jersey woman's gift to veterans more than just a blanket

While some people quilt to pass time and others quilt to make a decorative item as a gift for a loved one, Janice Jamison, 57, quilts as a way to give back to military veterans.

"I saw that the military hands the family of a fallen Soldier a flag," said Jamison. "I wanted to make something for the Soldiers that were just for them. So I started handing them quilts."

"Quilting is addictive and it feels good afterwards," said Jamison as she set up her display of a green, black, and red quilt with the many decorations dedicated to African-American military service members at the New Jersey Veterans Memorial Home at Menlo

Park on Feb. 23.

In cooperation with Operation Jersey Cares, an organization of dedicated people and veterans that provide support for wounded military service members, Jamison has handed out several hand-made quilts to New Jersey war veterans.

Consequently, she wanted to give a quilt to a Tuskegee Airmen, just as she had done for veterans of the Navajo Code Talkers several months back.

So she set out on her quest to find a living one here in New Jersey by sending letters to veterans groups, searching the Internet, and by asking people on the streets, said Jamison.

She knew that time was not on her side, as there are only a few number of living Tuskegee Airmen in the country, let alone in New Jersey.

But with luck and the help from a friend, Jamison was able to locate Lt. Charles Nolley.

"I used to bowl with him," said Delores Dorsey. "But I never knew he was a Tuskegee Airman."

Dorsey, a retired pharmaceutical employee from East Orange, contacted Nolley and set up a meeting for Jamison to hand deliver the quilt to Nolley.

Nolley, a Menlo Park resident, was an aviator with the 99th Pursuit Squadron, an African-American unit, and of the Tuskegee Institute training program.

"It's the thrill of the chase," said Jamison, a Union, N.J. resident, as she prepared to hand a specially crafted quilt to Nolley at the NJ Veterans Memorial Home at Menlo Park.

"It's not about the media attention or about the recognition," said Jamison. "I just want to give something back for their sacrifice."

They keep us safe at home, she said.

# JPMorgan Chase Announces New Programs for Military and Veterans Homeowners

*Commits to lower SCRA rates, increasing modifications, jobs, training, and home ownership help*

While bankruptcy is stressful for all of us, it may be more so for military service members and their families. Compounding the added strains of financial difficulty may be the fact of being stationed far from home and the added stress on family members that are left behind while struggling to maintain a household. To give the service member some piece of mind and allow them to concentrate on his or her job, the Servicemembers Civil Relief Act (SCRA) was signed into law on December of 2003.

This legislation was an update of the Soldiers and Sailors Civil Relief Act of 1940 and expanded many of that law's protections. Before these revisions, the SSCRA had remained virtually unchanged since 1940 and no updates had been added to reflect the changes in American life since that time.

Further improving these benefits, JPMorgan Chase announced Feb. 15 it will significantly enhance its programs to help military and veteran customers.

"The programs we are announcing today are a start, but in no way a finish," said Jamie Dimon, chairman and chief executive officer of JPMorgan Chase.

The bank will introduce a reduced SCRA pricing effective April 11, 2011, subject to any required approvals. Also, Chase will put in place a rebate or similar program for SCRA-protected military personnel, which will lower eligible borrowers' effective mortgage interest rate to four percent while on active duty and for a year thereafter. That maximum rate is two percent lower than the six percent rate currently required by SCRA.

As part of a Military Modification Program, which begins April 11, Chase will introduce an enhanced modification program for all members of the military who have served on active duty as far back as Sept. 11, 2001. The program will be offered to those who are delinquent or having trouble making their mortgage payments. Subject to the required regulatory and investor approvals, the program will go beyond the government's Home Affordable Modifica-

tion Program (HAMP) requirements. In addition, in cases when Chase modifies any Chase-owned or Chase-serviced primary residential mortgage, if there is a second mortgage on the same property that is also owned by Chase, Chase will modify the interest rate on the second mortgage to one percent.

Furthermore, as part of Chase's Home Ownership Assistance program, Chase will not foreclose on any currently deployed active military personnel. This change goes beyond current SCRA requirements, which protects military borrowers against foreclosure only if they took out their loans prior to going on active duty.

Chase believes they now have the systems and controls in place to avoid wrongful foreclosure proceedings on any military service member covered by SCRA. In cases where Chase has mistakenly foreclosed on military borrowers who should have been covered by SCRA, in addition to rescinding the sale, Chase will forgive all of the military service member's remaining mortgage debt. Going forward, if Chase ever has a wrongful foreclosure sale on an SCRA covered military service member, Chase will forgive all of their remaining mortgage debt, as well.

Chase will donate 1,000 homes to military and veterans over the next five years through Chase's non-profit partners.

By the end of 2011, Chase will open five new Chase Homeownership Centers in cities near the following large military bases.

1. Fort Hood, Texas
2. Naval Station Norfolk, Va.
3. Fort Bragg and Pope Air Force Base, N.C.
4. Camp Lejeune, N.C.
5. Fort Campbell, Ky.

In 2011, Chase will host 10 borrower outreach events near large military bases.

Chase will staff all of its Homeownership Centers with employees specifically trained in SCRA, military issues and Chase special military programs.

In addition, as part of a jobs initiative program, JPMorgan Chase will take sig-

nificant measurable steps to offer jobs and training to veterans by forming an alliance with other major corporate employers that commit to hire 100,000 military and veterans in total over the next ten years. Chase has already received commitments from several corporate partners and has reached out to many others. Chase will announce full details of the alliance in the coming weeks.

Chase will require all of its vendors to disclose its military hiring practices and will make contract decisions in part based on how strong are those programs. This is in addition to Chase's current practice of requiring vendors to disclose their diversity practices.

Chase's Education and Training program through its groundbreaking collaboration with Syracuse University, will now offer a Technology Education certificate exclusively for veterans to prepare them for technology careers. The program will be free to all military service members who have served on active duty since Sept. 01, 2001. It will be delivered online, so students can complete the coursework from any location. JPMorgan Chase employs 20,000 technology employees in the United States and will actively recruit graduates of the school to fill open roles.

Chase is also dedicated to forming a Veterans Advisory Council to advise the firm on these programs and other ways Chase can help the military and veteran community. The council will be chaired by Tom Higgins, JPMorgan Chase's head of Operational Control and Veterans Affairs. Higgins recently joined the firm after 24 years with the U.S. government. During his career in public service, he worked closely with all branches of the armed forces and served in the U.S. Navy.

## NJ Veterans Memorial Home at Menlo Park hosts events celebrating Black History Month

### Tuskegee Airman profiled at one event

One of the first things Shade Lee noticed after joining the Tuskegee Airmen during World War II was that racial segregation hurt the morale and efficiency of his storied unit, he told residents of the Veterans Memorial Home at Menlo Park on Feb. 23.

Lee, whose letter-writing campaign was credited with President Harry Truman's executive order ending racial segregation in the military, spoke to 30 residents as part of a month-long observation of Black History Month there.

The military career of a man who helped bring about Executive Order 9981 in 1948 began with him being barred to join the Army's Air Corps as an aviator, even though he had already taught himself to fly crop-dusting airplanes when he was a teenager. He was forced to enlist instead in the regular Army.

When the all-black 553rd Replacement Training Squadron was formed in 1943 at Walterboro, S.C., Lee joined the outfit as a training-aircraft repairman and immediately recognized how segregation hurt the unit's soldiers.

Lee went to work immediately looking for ways to demonstrate the ways segregation hurt the effectiveness of his unit.

"I felt strongly that assigning personnel should be based on the needs of the mission and what an individual can contribute," said Lee. "Not based on the color of their skin."

Lee said his suggestions to the military in the form of well-documented letters ultimately led to the end of segregation after the war.

Aside from being a pioneer in the concept of an integrated military, Lee also became an engineer after his military career and was instrumental in the toy, fashion, computer, and television industry.

"You are looking at the man who engineered the Easy Bake Oven," Lee announced to the gathered visitors at the veteran's home.

In addition, the veteran's home has held several events in February to commemorate Black History Month.

"We had several good events and guests at the center," said Joseph Brandspiegel, chief executive officer at the NJ Veterans Memorial Home at Menlo Park.

"The veteran's home also hosted this month a Caribbean heritage event, the Duke Ellington Legacy Band, and the famous 555th Parachute Infantry unit, which was nicknamed 'Triple Nickels,'" said Christine McNulty, supervisor of recreation for NJ Veterans Memorial Home at Menlo Park.

## National Guard Militia Museum Celebrates Women's History Month

### Exhibits at Sea Girt, Lawrenceville focus on pioneering role

SEA GIRT, N.J. - The National Guard Militia Museum of New Jersey (NGMMNJ) will open two Women's History Month exhibits celebrating the service of New Jersey's female soldiers, sailors, marines, and airmen. From the American Revolution forward, "Volunteering for Service: New Jersey Women in War" will highlight more than two centuries of service through photographs, primary source correspondence, period uniforms, and video excerpts from the museum's award-winning Center for U.S. Veterans' Oral Histories. The free exhibit opens on Mar. 1 and closes Mar. 31.

"Be it on the battlefield or the home front, the contributions of women in the major conflicts of American history must not be underestimated," said 1st Lt. Vincent Solomeno, museum curator and historian of the New Jersey National Guard. "In many ways, they are the unsung heroines whose dedication and bravery are examples to us all."

The museum at Sea Girt presents a chronological account of the contributions of New Jersey women to the U.S. Armed Forces. From the Battle of Monmouth Court House to female soldiers deployed in Iraq, the exhibit focuses on, among others, New Jerseyans Clara Barton, Clara Maass, and Maj. Gen. Maria Falca-Dodson, current commander of the New Jersey Air National Guard. Falca-Dodson holds the distinction of being the first woman promoted to the rank of general officer in the New Jersey National Guard.

The Lawrenceville Field Artillery Annex exhibit focuses on the ground breaking career of Col. Christine Haycock, who in 1952 became the first woman officer to serve as a physician in the U.S. Army Medical Corps. Following the Korean War, she became the first woman to hold a major command in New Jersey, with responsibility for the Army's 322nd General Hospital. The exhibit features photographs, memorabilia, and uniforms from Haycock's 38 years in military service.

"Volunteering for Service: New Jersey Women in War" opens Mar. 1 and runs until Mar. 31 at the National Guard Militia Museums in Sea Girt and Lawrenceville. The museum in Sea Girt is open Tuesday, Wednesday, and Thursday from 10 a.m. to 3 p.m., and the first, second, and third weekends of the month from 10 a.m. to 3 p.m. The Lawrenceville Field Artillery Annex is open Tuesdays and Fridays from 9 a.m. to 3 p.m. For more information, please visit the NGMMNJ web site at <http://www.state.nj.us/military/museum/> or call 1st Lt.
