Family Readiness Group recognizes volunteers

For Linda Pagan, spending a weekend outside a ShopRite collecting money to buy Valentine's Day cards for deployed Soldiers is just part of life as a Family Readiness Group volunteer.

Pagan was among 30 volunteers recognized at the Family Programs Awards luncheon on Oct. 3 for exemplary service in support of the National Guard's 50th Infantry Brigade Combat Team deployment.

Of those recognized, Pagan and Nancy Lacorte stood out. Each logged more than 600 volunteer hours. Both have sons who deployed to Iraq with the brigade.

Although both Pagan and Lacorte said supporting deployed Soldiers is the most important mission of the Family Readiness Groups, they believe the organization is obligated to help people with no military or veteran connections understand there are still New Jersey National Guard troops being sent into harm's way.

Lacorte recalled a woman who watched the 50th Chemical Company homecoming in Somerset and then asked: "Is the war over?"

"People need to understand that we are still deploying Soldiers and still have families left at home," Lacorte said.

Although volunteering involves long hours and hard work – think five-hour visits to the post office to mail hundreds of holiday cards – there are some fringe benefits.

Pagan's efforts to get celebrities behind the support effort led to a recent special package from her favorite New York Giant: quarterback Eli Manning.

"He sent an autographed picture and everything," she said.

Final step in post deployment takes place this month

The 50th Infantry Brigade Combat Team finished their historic deployment to Iraq in May. But the tour won't really end until the brigade's nearly 3,000 Soldiers have readjusted to the lives they left behind.

A final, formal step on that journey is taking place this month as the brigade's Soldiers undergo the last of its Yellow Ribbon Reintegration Program sessions. The third and final session is the 90-day post deployment health assessment. More than 1,000 Soldiers went through a three-day health screening at Fort Dix this past weekend and the rest are scheduled for later this month.

To Pfc. Peter Polo of the 102nd RSTA, the health screening meant a symbolic end to the deployment.

"Now that we're doing this, we know it's the last step before we go back to our regular drill schedule," he said. "We're all just happy to be home."

Maj. Gen. Glenn K. Rieth, the Adjutant General, addressed the Soldiers gathered at Fort Dix on Saturday and told them the health screening was crucial.

"This is an opportunity to medically reset you," Rieth said. "If you have a medical issue, take care of it now. Get it documented. I challenge you to ensure that the system works for you ... Your decision to serve puts you in an elite one percent of the population, I guarantee that the rest of America owes you something."

The health screening followed a Yellow Ribbon Reintegration program at 60 days that focused on mental health. The first Yellow Ribbon event involved the Soldiers and their families and focused on veterans benefits and a job fair.

Rieth told the Soldiers that while overseas deployments remain certain in the face of ongoing conflicts, the New Jersey National Guard should be able to focus its efforts on domestic missions, at least for now.

Do you know the little triangle with a number in it on the bottom of the plastic container? Here is a list of the seven categories of plastics, what is commonly made from each group and what they can be recycled into for their next life. Please check your local recycling rules for what you can put out at the curb on recycling day.

I PET (polyethylene terephthalate): Soda bottles; recycled into pillow fill.

2 HDPE (high-density polyethylene): Plastic milk bottles, detergent bottles; recycled into new detergent bottles.

3 PVC (polyvinyl chloride): Take-out boxes, shampoo; recycled into drainage and irrigation pipes.

4 LDPE (low-density polyethylene): Grocery bags, shrink wrap; recycled into new bags.

5 PP (polypropylene): Yogurt containers, bottle caps; recycled into plastic lumber.

6 PS (polystyrene): Packing peanuts; recycled into plastic lumber, cassette-tape boxes.

7 Other: Includes squeezable ketchup bottles and microwavable dishes; these items can't be recycled.

As the days get shorter, those electric and heating bills can start to rise. Here is a note that may help you save on your electric bill. Up to 10 percent of your electricity bill comes from powering appliances and home electronics that are turned off. Known as "phantom load," or "vampire power," it is the power used to keep your TV, stereo and other remote-controloperated devices in standby mode; run the digital clock on your microwave; and illuminate the little LED light on your cell-phone charger. One way to reduce vampire power is to plug these items into a power strip that can be switched off when they're not in use.

New retirement applications, procedures

The Division of Pensions and Benefits is implementing significant changes to retirement application procedures for members of the Public Employees' Retirement System (PERS), Teachers' Pension and Annuity Fund (TPAF), Police and Firemen's Retirement System (PFRS), and State Police Retirement System (SPRS).

There will be a new section listing "Terms and Conditions of Retirement" that employees will now need to review and sign off on, in order for their application to be accepted. If a member is applying through MBOS, there will be a check box the employee must check off, stating they have read, understood and agree to the terms and conditions.

Also, for retirements other than Deferred Retirement* the Division of Pensions and Benefits will no longer accept an application more than one year prior to the retirement date. For more information on these changes, a copy of the certified letter from Pensions and Benefits is available as a file attachment with an announcement on the DMAVAnet site under Human Resources. If you wish to obtain a copy of the New Application for Retirement Allowance form, please visit the DMAVAnet site under Human Resources > Benefit Forms, and Helpful Forms, as well as on the Pensions and Benefits website.

"Save for Retirement Week" designated for October 18-24

Congress has again passed a resolution to designate national "Save for Retirement Week" October 18-24. In New Jersey, the Division of Pensions and Benefits supports this effort to encourage Americans to save more for retirement. This year, we're using this opportunity to remind employees to save the environment as they save for retirement.

The New Jersey State Employees Deferred Compensation Plan (NJSEDCP) is a great way for employees to save for retirement. It also gives them opportunities to save the environment, through actions such as opting for online account statements.

Employees can also get "Save the environment, Save for your retirement" reusable bags from NJSEDCP Education Consultants during National Save for Retirement Week.

Open enrollment for state health plan 2010 begins Oct. 1

It's that time of year again! The State Health Benefits Program (SHBP) Open Enrollment period for all State employees will begin on Oct. I and end on Oct. 30, 2009. All changes to coverage made during this open enrollment will be effective on January 2, 2010, for State employees paid through the State Centralized Payroll Unit.

There are new documentation requirements if a member is enrolling a dependent for coverage (spouse, partner, or child). Along with the employer-certified *Health Benefit Applications* and/ or *Dental Plan Application* the following documents are required to verify the dependent's relationship to the member and eligibility for coverage.

- Employees who are enrolling a spouse as a dependent in the SHBP for the first time are required to provide a photocopy of the marriage certificate and a copy of the top half of the front page of the employee's most recently filed federal tax return (Form 1040*) that lists the spouse.
- Employees who are enrolling a child as a dependent in the SHBP for the first time are required to provide a photocopy of the child's birth certificate showing the employee's name as a parent.

If the employee's name is not on the birth certificate, the birth certificate and a copy of the top half of the front page of the employee's most recently filed federal tax return (Form 1040*) that lists the child may be submitted.

*Employees may black out all financial information shown on the form but the last 4 digits of any Social Security numbers.

Note: Additional documentation requirement information can be found on the SHBP Web site at: www.state.nj.us/treasury/pensions/shbp.htm. If you wish to enroll any dependents in the SHBP, and are not sure what documentation is required, please contact Benefits Administrator, Lisa J. Dandrea in Human Resources at 609-530-6888.

The State Health Benefits Commission has approved health, dental, and prescription drug plan rates for the 2010 plan year. The cost for health and prescription remains the same at 1.5 percent of the employee's salary. There will be a slight increase to the dental plan rates for state employees. NJ Vietnam Memorial Foundation to hold gala on Oct. 22 at Holmdel

Those who were so generous with their time and resources to help make the New Jersey Vietnam Veterans' Memorial a reality will be honored on Oct. 22 during the New Jersey Vietnam Veterans' Memorial Foundation's 7th annual "A Salute to Patriotism" gala.

The event will feature a 6 p.m. reception at the Vietnam Era Educational Center and a 7 p.m. dinner and program at the Robert B. Meyner Reception Center located on the grounds of the PNC Bank Arts Center in Holmdel.

Michael A. Fedorko, Vietnam Veteran and superintendent of police/director of public safety of the Port Authority Police Department will be the evening's featured speaker and honoree.

The foundation will also recognize the men and women who supported the initial concept for the Memorial and its subsequent building on the eve of the 15th anniversary of its dedication.

Hien Nguyen, designer of the Memorial and Thomas Jay Warren, sculptor of the statue that stands prominently in the center of the Memorial are slated to attend.

The Memorial was dedicated on May 7, 1995, the 20th anniversary of the end of the Vietnam War. It consists of a 200-foot diameter open-air pavilion containing 366 black granite panels. Each panel represents one day of the year. The panels are engraved with the name, date of birth and the date the New Jersey resident was killed or went missing.

There are presently 1,562 names on the Memorial.

VA warns Veterans of telephone prescription scam

WASHINGTON (Sept. 17, 2009) - The Department of Veterans Affairs (VA) is warning Veterans not to give credit card numbers over the phone to callers claiming to update VA prescription information.

"America's Veterans have become targets in an inexcusable scam that dishonors their service and misrepresents the Department built for them," said Dr. Gerald Cross, VA's Under Secretary for Health. "VA simply does not call Veterans and ask them to disclose personal financial information over the phone."

Veteran Service Organizations have brought to VA's attention that callers are misrepresenting the VA to gain personal information over the phone. They say VA recently changed procedures for dispensing prescriptions and ask for the Veteran's credit card number.

"VA has not changed its processes for dispensing prescription medicines," Cross said. "Nor has VA changed its long-standing commitment to protect the personal information of this nation's Veterans."

Scott.


