DIC is the payment made to a surviving spouse of a deceased service connected disabled veteran. The claim started in 2005. She received approximately \$17,000 in retroactive payments.

Joseph Battito, who is the VSO for the Middlesex/Somerset office, also assisted a veteran with 100 percent service connected disability to receive an additional \$1,000 a month in benefits, plus a special housing grant and \$14,000 in retroactive benefits.

State workers should look for changes in upcoming paychecks

On pay period 14 with a check date of July 13, the number of days in the fiscal year for twelve month employees increases from 260 days in Fiscal Year 2007 to 261 days in Fiscal Year 2008. For this reason, your biweekly gross wages may decrease slightly even though your annual salary has remained the same. For ten month employees, the number of days in Fiscal Year 2008 remains at 216 and, therefore, will not change the calculation of your biweekly salary.

required to contribute 1.5 percent of their annual base salary for health and/or prescription drug coverage under the State Health Benefits Program. Employees affected by this agreement will see the new deduction beginning with pay period 15 and a check date of July 27.

Effective July 7, for all members of the PERS and TPAF retirement systems employed by the Executive and Legislative Branch of State Government, the pension deduction will increase from 5 percent to 5.5 percent of compensation. Employees affected by this change will see the increased deduction beginning with pay period 15, and a check date of July 27.

New TSP account numbers being issued to make accounts more secure

Be on the lookout in late fall for a mailing from the Thrift Savings Plan (TSP) with your new TSP account number. This account number will replace your Social Security number as your primary ID for your TSP account. You will need to use your account number when filling in TSP forms. You will use it with your TSP password when entering the Account Access section of the TSP Web site. You will use it with your TSP Personal Identification Number (PIN) to gain access to your account through the ThriftLine. If you send the TSP loan payments from your own funds, you will need to include your account number on the loan coupon that accompanies your check or provide it to your on-line bill-paying service if you have one. Substituting this randomly selected account number for your Social Security number will make your TSP transactions more secure. We at the TSP are doing all we can to protect the security of your personal information. The rest is up to you. Be careful about giving out your account number, and don't write it down where it can be seen by others who should not have access to it.

Tax-free rules for deployed service members, families

From the Military Officers Association of America

Military pay received while deployed in a combat zone or other qualifying hazardous duty area is tax-free. But what specific rules apply? Here's a quick refresher course, which summarizes how you can take advantage of these savings opportunities.

All pay received (including base pay, special pays, and bonuses) is income tax-free up to the maximum enlisted pay rate of \$6,381.90 per month, plus imminent danger pay. Reenlistment bonuses received during a qualifying deployment month also are tax-free. Be aware, however, if a reenlistment bonus is taken in installment payments instead of a lump-sum, installment payments received after leaving the combat zone are not tax-free.

Thrift Saving Plan (TSP) contributions made while in a combat zone are not taxed on withdrawal or distribution.

Due to the Heroes Earned Retirement Opportunities (HERO) Act of 2006, servicemembers who were deployed in a combat zone or other qualifying hazardous duty area have up until May 28, 2009, to make IRA contributions for tax years 2004 and 2005. If the servicemember qualifies for a deductible traditional IRA, this can result in a tax refund for contributions made. For those under 50, the IRA contribution limits are \$3,000 for 2004 and \$4,000 for 2005. For those over 50, the limits are \$3,500 and \$4,500, respectively. You will need to file Form 1040X, Amended Tax Return. to claim any benefit. For more information. visit www.irs.gov/newsroom/article/0,,id=161175,00.html.

TSP is 20 years old and still helping government employees, military

This year, the Thrift Savings Plan (TSP) is celebrating its 20th birthday as the largest retirement savings plan of its kind – with more than 3.7 million participants and assets of approximately \$225 billion. Since 1987, the TSP has changed a lot. We've introduced four new funds and the L (Lifecycle) Funds, moved from a monthly to a daily valued plan, and brought the uniformed services on board. We've eliminated contribution restrictions (except for the IRS limits!), and participants continue to increase the amount they're saving for retirement. On average, we receive \$1.6 billion in contributions each month. Age now has its advantages, too, with the introduction of the age 50 and over catch-up contributions. Benefits and services also have been added (like the general purpose loans and the toll-free number for the ThriftLine). While participation and assets have been going up, the TSP's expense ratio has been going down – so you're saving even more!

Programs assist injured service members

WASHINGTON, July 5, 2007 - Servicemembers who've suffered serious injuries resulting from their wartime service can get financial help thanks to two congressionally legislated programs, a senior U.S. military officer said July 3.

Congress established the Traumatic Servicemembers Group Life Insurance program in 2005 in response to the experiences of some former and current military members who found themselves financially strapped after they suffered severe injuries during the war against terrorism. Coverage applies to active-duty and reserve-component members.

"This program provides up to \$100,000 per event, depending on (the type of) injury," Army Col. John Sackett, a disability compensation expert with U.S. Army Human Resources Command in Alexandria, Va., said during a telephone interview with online journalists and "bloggers."

All servicemembers covered under the Servicemembers Group Life Insurance program, whether active duty, reserve or National Guard, were enrolled for TSGLI coverage on Dec. 1, 2005.

To date, the Army has paid out a total of more than \$130 million under TSGLI, Sackett said.

The TSGLI benefit has both retroactive and prospective aspects, Sackett said. The benefit is provided retroactively for servicemembers who suffered severe combatzone-related injuries between Oct. 7, 2001, and Dec. 1, 2005, he said. The prospective aspect, he added, applies to servicemembers with injuries received "any time, anywhere" from Dec. 1, 2005, forward.

Currently, TSGLI doesn't offer compensation for veterans who've developed posttraumatic stress disorder as the result of battlefield service, Sackett said. "TSGLI hasn't allowed for that loss at this point in time," Sackett said. But, the U.S. Department of Veterans Affairs is working to include other types of injuries, including PTSD, under TSGLI program coverage, he said.

Yet, military veterans who suffer from combat-zone-related PTSD may be eligible for financial aid under the Combat-Related Special Compensation program, which became effective June 1, 2003, said Sackett, who is chief of the CRSC and TSGLI divisions at U.S. Army Human Resources Command.

The CRSC program provides compensation for eligible retired veterans with combatrelated injuries who have 20 years of military service and have received a U.S. Department of Veterans Affairs disability rating of 10 to 100 percent, Sackett said.

Sackett said the military is considering asking for congressional legislation that would enable medically retired servicemembers discharged under Chapter 61 to receive compensation for PTSD. There's also military interest in petitioning Congress for authority to provide compensation assistance to servicemembers with PTSD who have between one and 19 years of military service.
