<b>DEFINITION:</b>	<p>Under direction of a supervisor in a health care facility, provides nonprofessional nursing care and participates as a member of a treatment team; takes the lead over Human Service Technicians or Human Services Assistants; reports on patient's/resident's behavior and treatment related issues of a non-medical nature between shifts; works with patients/residents and their families and participates in the social, physical and emotional rehabilitation of patients/residents; does other related duties as required.</p> <p><b>SPECIAL NOTE:</b> Appointment to this may be made provisionally, pending the outcome of an open competitive examination (PAOC). If selected for the position and appointed PAOC, you will be required to apply for the open-competitive examination, when issued by the Civil Service Commission for this title, pass, and be reachable on the resulting eligible list to become permanent in the position. Appointees who fail to be reachable on the resulting eligible list are subject to removal</p> <p>This position is for the Department of Veterans Affairs which will become effective on January 9, 2026.</p>

Approved training may be obtained from a bargaining unit representative, the Human Resource Development Institute (HRDI), outside vendor, the Department of Human Services or the Department of Military and Veterans' Affairs.</p> <p><b>EXPERIENCE:</b> One (1) year of experience providing nonprofessional nursing care to children and/or adults in an institution, nursing home, or hospital.</p>				

<b>LICENSE / CERTIFICATION:</b>	Appointee will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform essential duties of the position.

<b>SAME APPLICANTS</b>	If you are applying under the NJ "SAME" program, your supporting documentation (Schedule A or B letter), must be submitted along with your resume by the closing date indicated above. <b>RESIDENCY:</b>	Effective 9/1/11, NJ PL 70 (NJ First Act), requires all State employees to reside in New Jersey, unless exempted under the law, or current employees who live out-of-state and do not have a break-in service of more than 7 calendar days, as they are "grandfathered." New employees or current employees who were not grandfathered and who live out-of-state have one year after the date of employment to relocate their residence to New Jersey or request an exemption. Current employees who reside in NJ must retain NJ residency, unless he/she obtains an exemption. Employees who fail to meet the residency requirements or obtain an exemption will be removed from employment.
<b>DRUG SCREENING:</b>	If you are a candidate for a position that involves direct client care with the Department of Military and Veterans Affairs, you may be subject to pre and/or post-employment drug testing/ screening. The cost of any pre-employment testing will be at your expense. Candidates with a positive drug test result or those who refuse to be tested and/or cooperate with the testing requirement will not be hired. You will be advised if the position for which you're being considered requires drug testing and how to proceed with the testing.
<b>INFLUENZA VACCINATION:</b>	NJ State Law (N.J.S.A. 26:2H-18.79) requires <u>ALL</u> health care facility employees to have the influenza vaccination annually.
