The dedicated and professional citizen-soldiers of the New Jersey Army and Air National Guard continue to support their mobilized colleagues deployed throughout the world in support of Operations Iraqi Freedom, Enduring Freedom, and Noble Eagle as well as Family Assistance activities which benefit our military families here at home. It's been a long 41 months since September 11th, but finally, some of our personnel have completed their tours and are returning home.

As our fellow citizen-soldiers rotate back from their extended deployments, it is incumbent upon all of us to ensure that this transition process meets their needs, the needs of their families, and the needs of their civilian employers.

First and foremost we need to give our troops appropriate recognition for their service. The successful homecoming events we already have conducted for returning units has been a good, first step towards accomplishing this goal.

Second, we need to assure a smooth transition from a combat environment back to civilian life. We need to make

sure that all returning Guardmembers receive every benefit and entitlement they have earned by virtue of their patriotic service.

Finally, for those individuals who need assistance, we need to eliminate any possible hesitation they may have in applying for help by eliminating unnecessary bureaucracy and making these support services more accessible.

At DMAVA, we have the added benefit of having the Division of Veterans Programs and its substantial resources right here within our organization. Part of our plan to facilitate the transition of our returning soldiers and airmen includes the active participation of expert veterans services personnel, the members of our New Jersey Employer Support of the Guard and Reserve Committee, our extended Family Programs staff, and our chaplain corps. We have developed a comprehensive, multi-level, inter-organizational approach that integrates our state Veterans Service Officers with their associated and related Army and Air military activities. Families have the option of participating in "return home workshops" available through each of our Family Readiness Groups.

However, the effort to address the needs of our returning troops and their families should not end with merely making services or resources more readily available. The "Total Guard", which includes family, friends, colleagues, community, unit commanders, and the entire chain of command, needs to be proactive. We all must be part of the effort to encourage our returning heroes to seek the assistance and resources that can make their homecoming less challenging.

I urge each and every returning soldier or airman and their family members to take full advantage of the services and assistance we can provide. Do not try to handle this difficult transition alone. When you were called to extended active duty service, you answered. Now it's our turn to demonstrate our profound gratitude for your selfless service, to show our collective appreciation for the many hardships and sacrifices both you and your families had to endure; and to give back to each of you, in some way, a small part of the tremendous gift you have given us and all the people of America. 🇺🇸

177th Medics Demonstrate New Decon System

The 177th Fighter Wing Medical Group demonstrated the new In-Place Patient Decontamination Capability (IPPDC) facility to members of the University of Medicine and Dentistry, New Jersey Center for Biodefense and local emergency medical service units Nov. 18.

The mobile decontamination facility – a specially designed tent, is the first of its kind at a New Jersey Air National Guard base. It is designed to decontaminate both ambulatory and non-ambulatory victims exposed to biological or chemical agents before they enter a medical facility. Decontamination team members wear protective suits during the process.

The process is simple: before entering the facility, victims are asked to place their clothes and personal effects into a plastic bag that is tagged with a serial number. A tag is then tied to the patient's wrist to account for the victim's belongings. The patient then enters the tent, which contains a shower area, to clean and rinse off.

Victims who are unable to clean themselves are placed on a stretcher. The team removes the victim's clothing and places the patient and stretcher on a 16-foot long track. As the victim is rolled down the track,

the team thoroughly washes the patient to ensure he or she is decontaminated. After the victims are cleaned, they are then transported to a medical facility for evaluation and treatment.

The 177th Medical Group is one of two decontamination teams in the Federal Emergency Management Agency, Region II area, which covers New Jersey and New York.

Cadets ChalleNGe Life At Fort Dix

The New Jersey National Guard ChalleNGe Youth Program is in business to give the youth of New Jersey a second chance at life.

A majority of the cadets who graduate the program go on to receive their GED and become productive members of society. Many seek higher education, and some choose to join the military and help to fight the Global War on Terrorism. But that's no surprise to Col. (Ret.) Kenneth Prossick, Director, Challenge Program.

"At the ChalleNGe Youth Program, we take 16-18 year-olds who have quit high school, for whatever reason, and give them a second chance at a high school diploma," stated Prossick. "We bring them to Fort Dix for a 22-week residency program and put them through the regimen of a military-style program. We help them change their attitudes and hopefully when they graduate they will have earned or be well on their way to attaining a high school diploma."

The program, which is run by the National Guard and is active in 22 states, seeks to identify at-risk teenagers who have dropped out of high school, and gives them the motivation and direction they need to complete their schooling. Applicants must be New Jersey residents between 16-18 years old, drug-free, and not currently involved in the legal system.

Although its military style program is similar to boot camps that work with juvenile delinquents, the ChalleNGe Program does not work with teenagers already in the justice system or on probation. It does, however, utilize some of the techniques used by the military to motivate soldiers during basic training. And just like the military, the ChalleNGe program is strictly voluntary.

"Our core curriculum works towards academic excellence," says Prossick. "We focus on reading, writing, math, social studies and science. We also 'go heavy' on developing life skills – leadership, follower-ship, health and hygiene, citizenship, physical training of course, and we run this routine 24 hours a day, seven days a week, for 22 weeks."

The cadets learn the importance of community service by shovelling snow for families of deployed

soldiers at Fort Dix. They also have assisted with several Salute The Troop ceremonies.

This 24/7 program takes place at Fort Dix, a military facility that used to be responsible for the basic training of United States Army Soldiers until about 15 years ago. The facilities at Fort Dix are perfect for the ChalleNGe Program, and Prossick and the other instructors make sure that they take full advantage of them.

"All the assets of Fort Dix are available to us as are the assets of the New Jersey National Guard, and we make full use of those assets."

Mentoring is an important part of Phase Two of the program. After completion of Phase One, the 22-week resident phase, adult mentors are assigned to each cadet after they leave Fort Dix.

The ChalleNGe Youth Program is now the second largest mentoring program in the nation, and may be just the ticket for those teenagers who have left school and who feel they have lost direction in their lives. 🇺🇸

Troops And Employers Face Challenges

Since September 11, 2001, more than 4,000 New Jersey National Guard soldiers and airmen have been mobilized for federal active duty service in support of Homeland Defense or Homeland Security missions.

These soldiers and airmen responded to a national emergency; serving honorably around the world. And now, their active duty service obligations satisfied; their mission accomplished; their mobilization over; our troops are coming home and returning to their civilian workplace.

But not since World War II has this large a number of mobilized citizen-soldiers returned to the workplace after an absence of up to two years. In the days of an all-volunteer force, one might assume an absence of conflict between military service and other, primary obligations to family and employer. But as we have heard so often, *The soldier may have volunteered... but the family and employer didn't volunteer.*

The ESGR (Employer Support of the Guard and Reserve) Committee provides guidance and assistance to both citizen-soldiers and their civilian employers to help prevent any frictions that may arise between military service obligations and the civilian career. This support mechanism carries over into periods of mobilization and deployment. Employer obligations to their employees are clearly defined and enjoy the benefit of strict guidance from federal law. Title

38 USC, USERRA (Uniformed Services Employment Re-Employment Rights Act), and the Soldiers and Sailors Civil Relief Act provide a comprehensive road map on how to deal with most military service/workplace contingencies. However, given the unprecedented numbers of



Guardsmen and Reservists mobilized for the ongoing war against global terror, Homeland Security, and Homeland Defense missions, the magnitude of the impact on families and employers alike also, has been unprecedented.

The transition process of converting citizens to soldiers is adequately addressed during pre-mobilization training and mobilization. But there is no formal training for employers who have little experience in re-assimilating employees returning from combat or other military duty.

To begin to address these concerns and issues, the New Jersey Business & Industry Association (NJBIA) together with the New Jersey League of Municipalities (NJLOM) in conjunction with the New Jersey Department of Military and Veterans Affairs and the New Jersey Committee for Employer Support of the Guard and Reserve will be conducting a

seminar at the Foresgate Country Club on Mar. 11 designed to provide employers with information that can assist them through the re-assimilation process.

With the return of several NJARNG units, ESGR and NJDMAVA were provided a unique opportunity to observe and analyze the re-assimilation phenomenon and begin to assemble information based upon the actual experiences of returning troops and their civilian employers.

Bill Dressel, Executive Director, NJLOM, stated "With large numbers of municipal employees actively serving in the Guard or Reserve, municipal employers were among the hardest hit by the mobilization of specialized skill employees in the categories of police, fire, and emergency services personnel. Absences of key personnel resulted in increased payroll expenditures and put additional strain on fellow employees who were required to pick up the slack by working extra shifts and overtime."

According to Chief Master Sgt. (Ret) Hank Pierre, Executive Administrator, NJESGR, "Civilian employers were an important part of the support team that enabled our troops to complete their active duty service successfully. Now, during "return" phase of the demobilization process, it's our turn to demonstrate our appreciation for the solid support and many sacrifices our employer community so willingly made." 🇺🇸
