DEPARTMENTAL DIRECTIVE
NO. 799

1 October 2007

**HUNTING AND FISHING LICENSES FOR ACTIVE MEMBERS OF THE
NEW JERSEY ARMY AND AIR NATIONAL GUARD**

- 1. PURPOSE:** This Directive prescribes the policy for the issue of New Jersey Hunting and Fishing Licenses.
- 2. APPLICABILITY:** Only active members of the New Jersey Army and Air National Guard, who have completed Initial Active Duty Training (BCT and AIT), are authorized to make application.
- 3. REFERENCE:** New Jersey Assembly Bill 1565 dated 11 June 1993, which amends Section 12 of Public Law 1983, c.324 (C.13:1L-12).
- 4. OBJECTIVE:** To provide no fee issue of licenses, permits, stamps, tags or certificates to hunt, fish or trap in New Jersey to active members of the New Jersey Army and Air National Guard.
- 5. AUTHORIZATION:** The Division of Fish, Game and Wildlife (DFGW), New Jersey Department of Environmental Protection (DEP) has designated the Administrative Services Bureau (ASB), New Jersey Department of Military and Veterans Affairs (NJDMAVA) as a license-issuing agent for the issuance of free Hunting and Fishing Licenses to active members of the New Jersey Army and Air National Guard.
- 6. RESPONSIBILITY:** The Chief, Administrative Services Bureau, New Jersey Department of Military and Veterans Affairs shall have the responsibility for the effective management of the program.
- 7. PROCEDURES:**
 - a. All applications for licenses and/or stamps will be submitted by U.S. Mail to:

b. Resident of the State of New Jersey: The application of a resident active member of the New Jersey National Guard for a license or stamp shall be submitted on NJDMAVA Form 799-1 (Figure 1).

c. Non-resident of the State of New Jersey: The application of a non-resident active member of the New Jersey National Guard for a license or stamp shall be submitted on NJDMAVA Form 799-2. (Figure 2)

d. Rifle Permit. The application for a resident or non-resident active member of the New Jersey National Guard for a rifle permit shall be submitted on NJDMAVA Form 799-3. (Figure 3).

e. Turkey Permit. The application for a resident or non-resident active member of the New Jersey National Guard for a Turkey Permit shall be submitted on NJDMAVA Form 799-4 (Figure 4).

f. Deer Permit. The application for a resident or non-resident active member of the New Jersey National Guard for a Deer Permit shall be submitted on NJDMAVA Form 799-5. (Figure 5).

g. In order to expedite the process, individuals are encouraged to submit applications with a self-addressed stamped envelope.

8. ACTIVE MEMBERSHIP: In order to prove active membership in the NJNG, an original member's Leave and Earning Statement (LES) must be forwarded with application. The LES must be dated within 90 days of the application and show active training during that period. Copies of LES are not accepted.

9. APPLICATIONS: Only NJ National Guard applications will be accepted. Incorrect, incomplete or applications found in Fish and Wildlife Digest will not be accepted for issue of a National Guard Hunting License, Fishing License or Special Hunting Permits. LES and Supplemental Application or Certification Certificate (Child Support) from Division of Fish and Game must also be attached to application. For issue of an All-round, Firearm, Bow or Trapper License, an original previous license or an original NJ Hunter Safety Course Card for the type of license applied for must be attached to application. A resident license from another state will be accepted for issue of a New Jersey Resident or Non-resident Firearm and/or Bow License. Non-resident licenses from other states will not be accepted for issue of a New Jersey Firearm and/or Bow License. A previous license is not required for issue of a Fishing License. All licenses and documents will be returned to applicant. Local Hunting License Sales Offices are not authorized to accept applications or issue free Hunting, Fishing licenses or Turkey and Deer Permits to active National Guard personnel.

10. SPECIAL HUNTING AND FISHING STAMPS: If hunting or fishing license was issued by DMAVA; stamp(s) will be issued by submitting current year's license number on application. If license was issued by local license-issuing agency, LES and current year's license must be submitted with application. Hunting and/or Fishing License will be verified and license and stamp(s) will be returned by U.S. Mail. Stamps are not issued with Trapper License.

11. LICENSE IS VALID FOR ONE YEAR: All New Jersey Hunting and Fishing Licenses are valid for one year from 01 January to 31 December. Licenses for upcoming year will not be issued prior to 24 December and will not be valid until 01 January of the New Year.

12. RIFLE PERMITS: New Jersey Rifle Permit Application with previous Rifle Permit attached must be submitted to be issued a New Jersey Rifle Permit. A Rifle Permit is required in addition to a New Jersey Firearm License when muzzleloader hunting or other rifle hunting and trapping. Rifle Permits are valid for one year from 1 June to 31 May.

13. SPECIAL HUNTING PERMITS: Special Turkey and Deer Hunting Permits will be issued in accordance with Division of Fish and Game requirements and regulations. Applicant must have current Hunting License prior to submitting application for a Turkey or Deer Permit. If current license was issued by DMAVA, license number must be indicated in the license number section of the application. If license was issued by a local license-issuing vendor, license must be attached to application. License will be verified and returned. Only NJ National Guard applications will be accepted. Do not submit application found in Fish and Wildlife Digest.

a. **TURKEY PERMITS.** Applications must be submitted and received at this office NLT the close of business of the cut-off-date mandated by the Division of Fish and Game. Applicants may submit applications for the first and second spring hunting seasons and for the fall hunting season at no charge. Be sure to indicate hunting area and hunting period on the spring hunting section and the hunting area on the fall section of the Turkey Permit Application. Note that the fall hunting areas are limited to only areas indicated on the application.

b. **DEER PERMITS.** Applications must be submitted and received at this office NLT the close of business of the cut-off-date mandated by the Division of Fish and Game. Applicants may submit applications for the first and second lottery for bow and/or firearm at no charge. Choice of (S) for shotgun or (M) for muzzleloader must be indicated in the firearm section of the application. Be sure to indicate zone choices on Application. All permits will be issued for antlerless deer hunting only. To hunt antlered deer and be issued an Antlered Buck Bonus Permit, the antlered buck section must be checked on the application.

14. ALL-ROUND SPORTSMAN LICENSE: All-Around Sportsman Hunting License is a combination Bow & Arrow, Firearm and Fishing License. If applying for All-Around Sportsman License, **DO NOT** apply for a separate Fishing License.

15. REQUESTS FOR DUPLICATE/REPLACEMENT LICENSE: All requests for duplicate/replacement licenses for active NJ National Guard personnel should be addressed to this office. Replacements for lost or damaged licenses will be issued to NJNG members at no cost.

16. SUPPLEMENTAL APPLICATION (CHILD SUPPORT): Division of Fish and Game Supplemental Application (Child Support) is required by the State of New Jersey prior to issue of a Hunting and/or Fishing License. Supplemental applications are valid for one year, 1 January to 31 December, and must be renewed yearly. If supplemental license application or certification certificate is not submitted with NJ National Guard Hunting and Fishing application, one will be mailed to applicant and must be returned prior to issue of license. The supplemental license

application must be filled out completely and clearly and signed by applicant. Supplemental application must be returned to this office within 30 days or original application will be rejected. Supplemental (Child Support) certification may be obtained on line from Division of Fish and Game and must be attached to New Jersey Hunting application.

17. FIREARM PURCHASE & IDENTIFICATION CARDS: Firearm purchase or identification cards are not accepted for issue of a New Jersey Hunting License or Rifle Permit.

18. Only DEP, DFGW or NJDMAVA are authorized to issue flyers, posters or instructions concerning license issue. Applications may be copied at local level but not changed in any form.

ORIGINAL LES SHOWING ACTIVE TRAINING WITHIN 90 DAYS OF APPLICATION PLUS PREVIOUS NEW JERSEY RIFLE PERMIT, OR AN ORIGINAL NEW JERSEY RIFLE SAFETY COURSE CARD OR THE RENEWAL CARD FROM DIVISION OF FISH, GAME AND WILDLIFE, MUST BE SUBMITTED WITH APPLICATION.

1. RIFLE PERMITS ARE ISSUED FOR A ONE YEAR PERIOD, 1JULY THROUGH 30 JUNE AND IS FOR THOSE USES AND SEASONS PRESCRIBED IN THE CURRENT GAME CODE.
2. A RIFLE PERMIT IS REQUIRED, IN ADDITION TO A REGULAR NJ HUNTING LICENSE AND SPECIAL DEER PERMIT, WHEN MUZZLELOADER HUNTING.
3. THE CARRYING OF A RIFLE IN THE WOODS, FIELDS OR ON THE WATERS WITHOUT A LICENSE AND A VALID RIFLE PERMIT, OR ITS USE IN HUNTING OR KILLING BIRDS OR ANIMALS NOT COVERED BY THE PERMIT, OR AT THE TIME OF YEAR WHEN THERE IS NO OPEN SEASON FOR HUNTING COULD RESULT IN PROSECUTION AND REVOCATION OF PERMIT. CONSULT YOUR CURRENT DIGEST OF GAME LAWS.
4. TRAPPERS POSSESSING A VALID RIFLE PERMIT FOR USE OF A .22 CALIBLER RIFLE ON A TRAPLINE, MAY DISPATCH LEGALLY TRAPPED FURBEARERS, EXCEPT MUSKRATS; HOWEVER, A FIREARM MAY NOT BE CARRIED ON A SUNDAY. A TRAPPING LICENSE IS ALSO REQUIRED WHEN TRAPPING.
5. FIREARM PURCHASE AND/OR IDENTIFICATION CARDS ARE NOT ACCEPTED FOR ISSUE OF A RIFLE PERMIT.
