# 2207-01 Proposed amendment to the provisions of N.J.A.C 13:21-23.1, 23.24 and 23.28, pertaining to commercial driver licensing and mandatory lifetime revocation of a person's commercial motor vehicle (CMV) driving privileges.

This is a proposed amendment. The proposed rules together with the underlying legislation will positively impact public safety by permanently disqualifying persons who have been convicted of crimes of human trafficking from operating a CMV without eligibility for reduction of such disqualification. In accordance with federal law and the underlying legislation, the proposed amendments impose a mandatory lifetime revocation of a person's CMV driving privileges and bar a person from applying for the restoration of such privileges in the future, if that person is convicted of an act or practice of human trafficking in violation of New Jersey law, or of "severe forms of trafficking in persons" in violation of federal law.

Vice Chair, Diane Gutierrez-Scaccetti moved the resolution, Board Member Steve Scaturro seconded it and it was unanimously adopted.
