## MOTOR VEHICLE COMMISSION Notice of Receipt of Petition for Rulemaking Petition for New Rules Vehicles Abandoned at Repair Facilities Procedure and Defective or Improper Titles Procedure

Petitioner: Michael Sassano, Jr., Recovery Solutions and Title, LLC.

Take notice that on December 17, 2019, the New Jersey Motor Vehicle Commission (MVC) received a petition for rulemaking from Michael Sassano Jr., of Recovery Solutions and Title, LLC, seeking amendments to existing regulations and/or for new rules to allow for a search of the National Motor Vehicle Title Information System (NMVTIS) to determine proof of vehicle ownership and lienholder information for vehicles abandoned at repair facilities, pursuant to N.J.S.A. 39:10A-8 et seq., and for vehicles where the bona fide purchaser does not have the proper documentation to apply for a certificate of ownership (title) from the MVC, pursuant to N.J.S.A. 39:10-16. The petitioner proposes that applicants under either procedure be permitted to first conduct a NMVTIS search to determine ownership and security interests, before being required to perform a search of the five states surrounding New Jersey, as is the current procedure. The purpose of the petitioner's request is to reduce the applicant's financial burden associated with the five-state

search. The petitioner proposes that the five-state search should only be required if the New Jersey Motor Vehicle Commission and NMVTIS searches return no record results. The petitioner further proposes that the MVC revise its procedure with regard to vehicles abandoned at repair facilities

In accordance with the provisions of N.J.A.C. 1:30-4.2, the Chief Administrator will subsequently mail to the petitioner, and file with the Office of Administrative Law, a notice of action on the petition.
