**PERFORTATON:** Part one to be perforated with 4 point rule score 5/8" from top. Part two is **NOT** to be

perforated.

**TYPOGRAPHY** 

& LAYOUT Vendor shall be provided with rough layout of form and must prepare all electronic files including on the face of Part One and all of the security

features that print.

**PART 1** The design will include a border printed in detail high resolution printing,

pantographing in 2 colors and text. Border and text printed same color inks.

Pantographing prints in 2 PMS color inks. No back printing.

SECURITY FEATURES TO BE INCLUDED ON PART ONE (1) ONLY.

PART 2 Prints same text as Part One in Black Ink. No security features and no back printing

on Part Two.

**PAPER:** The form should be printed on paper that when altered with a chemical agent such

as ink eradicator will expose the word void or copy.

**MICROLINE:** The form will include a phrase to be determined by the Commission to be printed

.008 inch high. This will appear as a dashed line to the naked eye and will be only visible under magnification. The border of the form will be printed in detailed high

resolution printing.

The body of the form will include a two color pantograph. This pantograph will incorporate the word void or copy which will appear when attempts are made

to photocopy on a color copier.

**NUMBERING:** A sequential control number to be imprinted on the face of each document in Black

**PACKING:** Packed 20 books to a nylon web tape sealed individual mailing carton. Individual

carton to bear serial number of documents contained therein with a return address mailing label. (3) Individual cartons to be repacked into larger cartons of uniform size, containing equal quantities. All cartons must be affixed with a label indicating quantity per carton, vendor name, P.O. number, form number, a 3 of 9 bar code and description. Cartons must be palletized on skids in numerical sequence with lowest

number carton on top and highest on bottom of skid. Skid not to exceed 40" in width

and 48" in length. Pallets must be secured with stretch wrap. Height must not exceed 48" including pallet.
