TO COMMERCIAL DRIVER LICENSE HOLDERS AND LIMOUSINE DRIVERS APPLYING FOR A PASSENGER ENDORSEMENT

NOT FOR SCHOOL BUS OR HAZMAT DRIVERS

The Motor Vehicle Commission (MVC) requires passenger (P) endorsement applicants to be fingerprinted and submit to a criminal background check. The successful completion of a criminal background check is a legal requirement as a condition for employment for commercial driver license (CDL) holders applying for a P endorsement to transport passengers for hire. Limousine driver applicants who obtain a CDL and successfully pass the P endorsement criminal background check, are not required to be fingerprinted under the New Jersey limousine statute 48:16-22.3A.

Effective February 17, 2020, P endorsement applicants must schedule a fingerprint appointment with the State's fingerprint vendor at the company's website, <u>https://uenroll.identogo.com</u>. Applicants who do not have internet access may schedule an appointment by contacting IdentoGo at 1-877-503-5981. Applicants will be required to make a one-time payment to cover all required background checks and vendor fees. Fees will be payable at the time of service. Visa, MasterCard, money orders and checks are acceptable forms of payment. No cash will be accepted. Please make money orders payable to IdentoGo.

The following information will be required when scheduling a fingerprint appointment:

Applicants may visit a Motor Vehicle Agency upon receipt of the IdentoGo confirmation email containing the payment confirmation number (PCN); however, the applicant must print the confirmation email and bring it to the MVC agency to obtain the passenger endorsement. Applicants must provide an email address when scheduling a fingerprint appointment in order to receive a confirmation email with the PCN number.

Applicants who provided an email address and did not receive a confirmation email with the PCN number must wait 3 - 5 business days before visiting a Motor Vehicle Agency to obtain the passenger endorsement.

Please note: The Department of Education (DOE) school bus (S) endorsement applicants are required to be fingerprinted by the Department of Education and must submit the DOE Applicant Approval Employment History document to the Motor Vehicle Agency at the time of the licensing transaction. Hazmat (H) endorsement applicants must be fingerprinted by the Transportation Safety Administration.

Limousine driver applicants must be fingerprinted under <u>N.J.S.A</u>. 48:16-22.3a. Limousine driver applicants who have a CDL with a passenger endorsement are not required to be fingerprinted under <u>N.J.S.A</u>. 48:16-22.3a.

Failure to get fingerprinted under the appropriate statute will require the applicant to submit to an additional background check and pay the associated fees. No refunds will be issued.
