

**APPLICATION FOR MOTORCYCLE OR MOPED TITLE**

INSTRUCTIONS

To title a Motorcycle or Moped, the following is required:

1. A legible photograph of the motorcycle or moped being titled. The photograph must show a profile of the vehicle being titled and show all features such as a seat and pedals (if applicable).
2. A legible photograph of the National Highway Traffic Safety Administration (NHTSA) label certifying that the vehicle conforms to Federal safety standards for that model year.
3. A legible photograph of Environmental Protection Agency (EPA) Emission Label certifying that the vehicle conforms to EPA regulations for the model.
4. A legible photograph of the EPA noise label certifying that the vehicle meets federal noise limits.
5. **ALL PHOTOGRAPHS BECOME THE PROPERTY OF THE NEW JERSEY MOTOR VEHICLE COMMISSION.**
6. Manufacturer's Certificate of Origin, Manufacturer's Statement of Origin, Title (Certificate of Ownership), or notarized bill of sale and registration.

New Jersey has two classifications of Motorcycles / Motorized Bicycles (Mopeds):

1. A Moped must be less than 50CCs, operate under 25 MPH per the manufacturer's specifications, and have operable pedals. The operator of a Moped must be at least 15 years of age or older and possess a moped, motorcycle-only, basic auto, or CDL license.
2. Any other two- or three-wheeled vehicle is considered to be a Motorcycle (except for electric and low speed vehicles under 25 MPH per the manufacturer's specifications). The operator of a Motorcycle must be 17 years of age or older and possess a motorcycle-only license or motorcycle endorsement.
