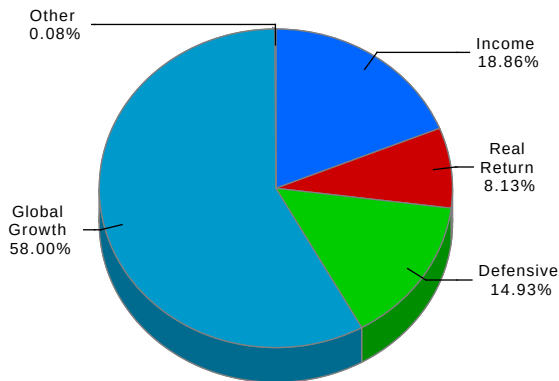

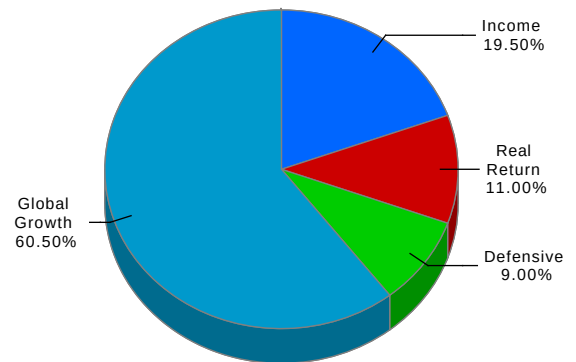

**Current Asset Allocation**



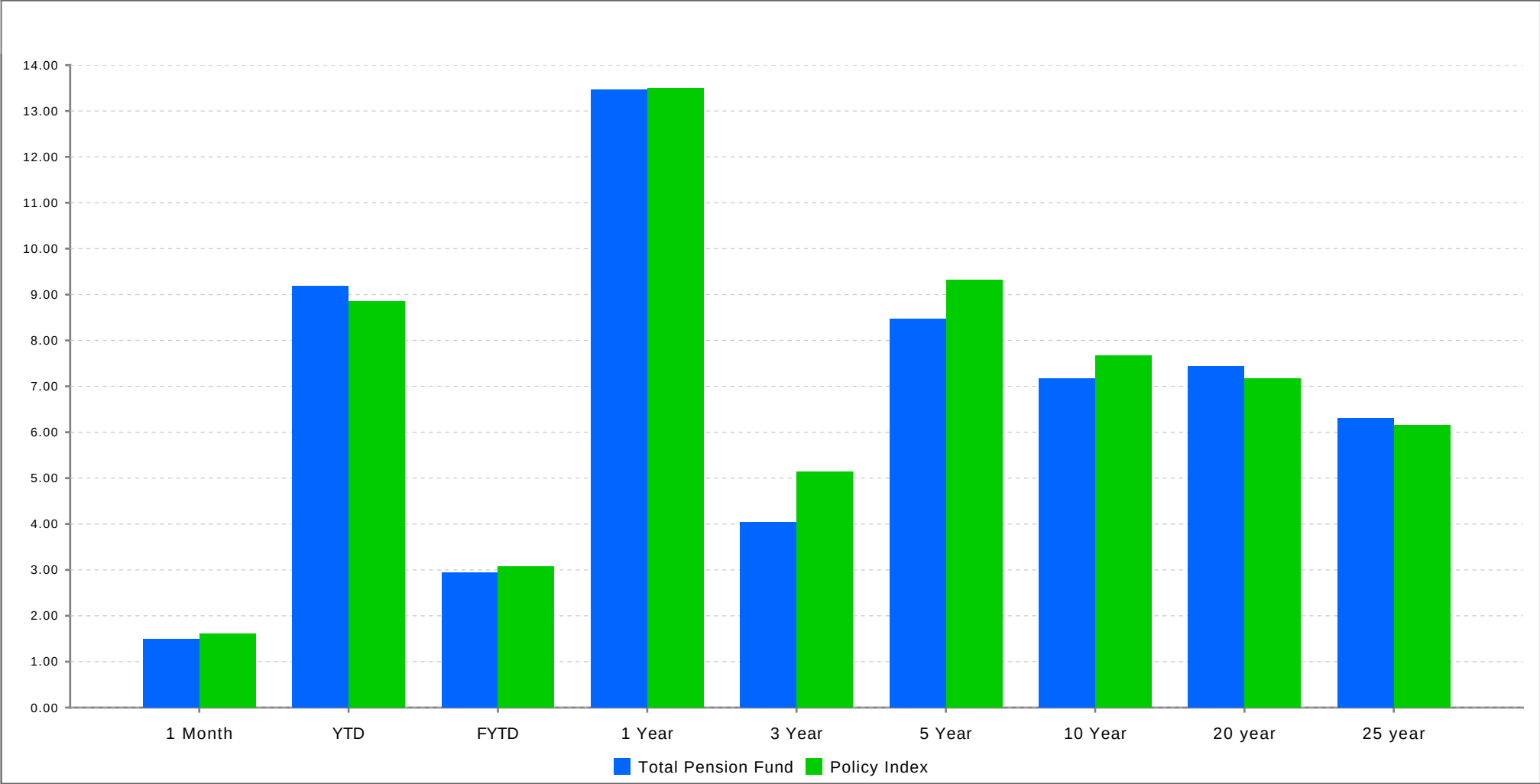
**Target Asset Allocation**

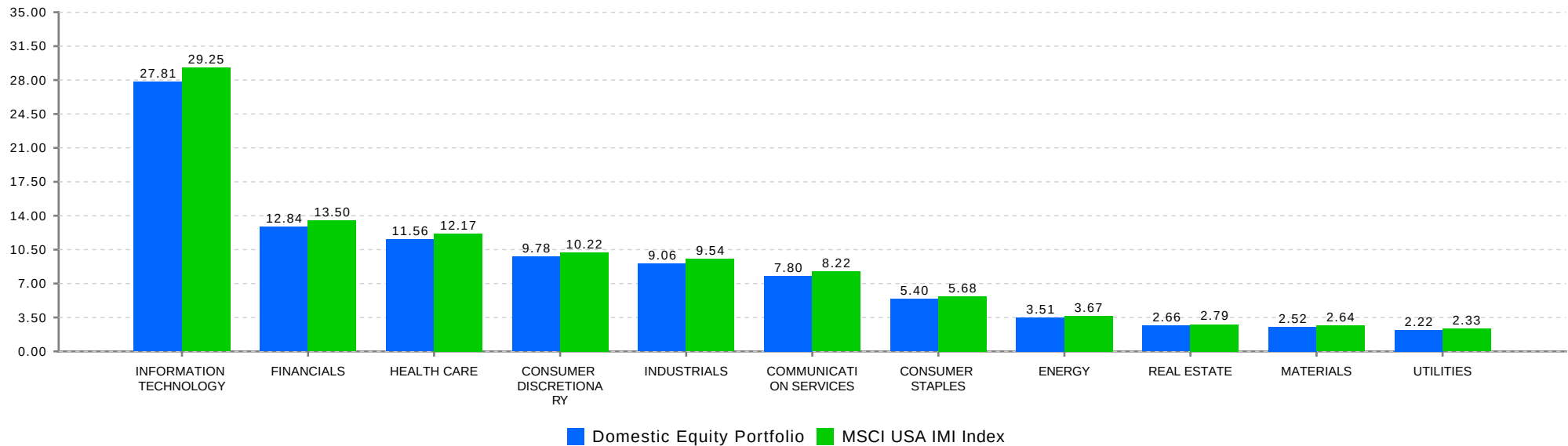

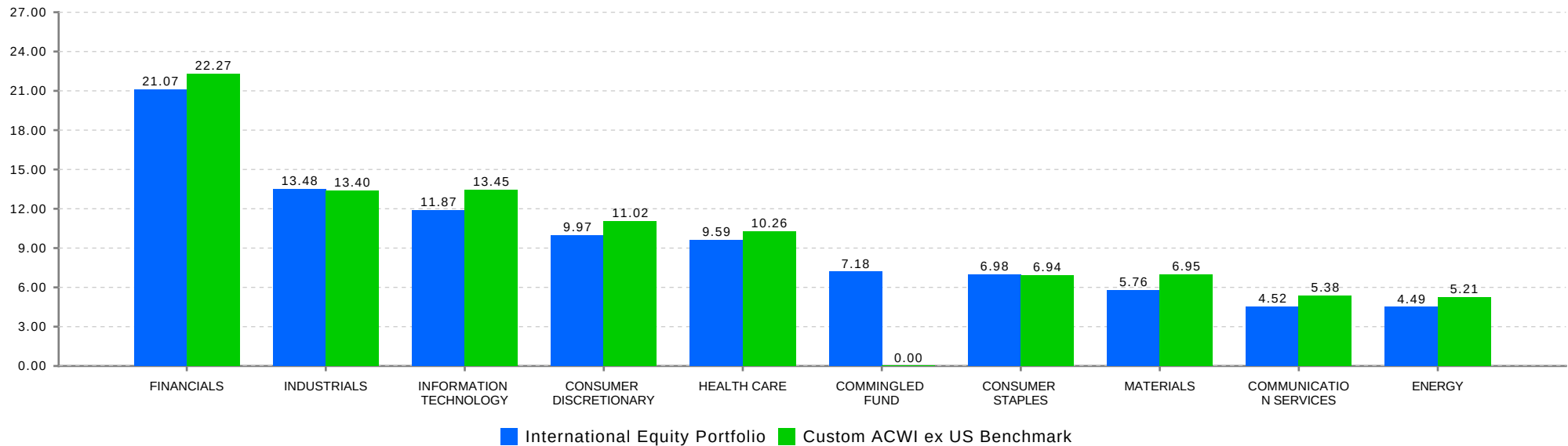

International Equity**



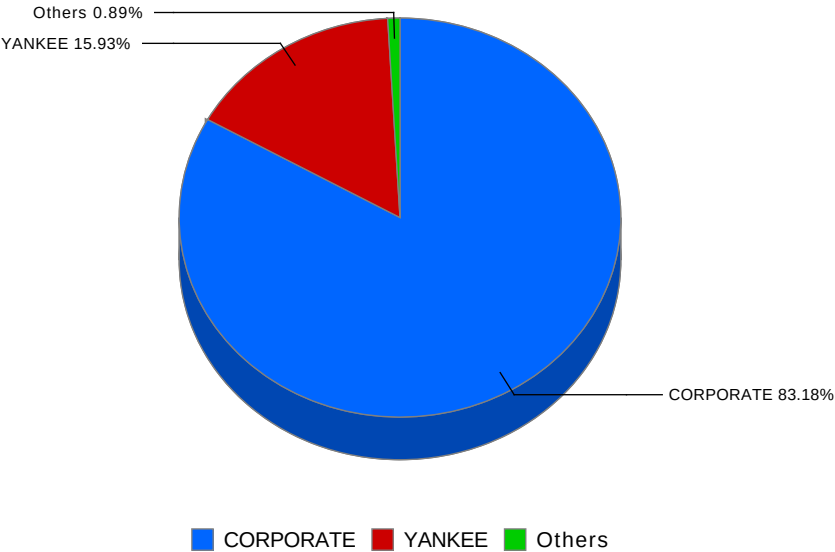

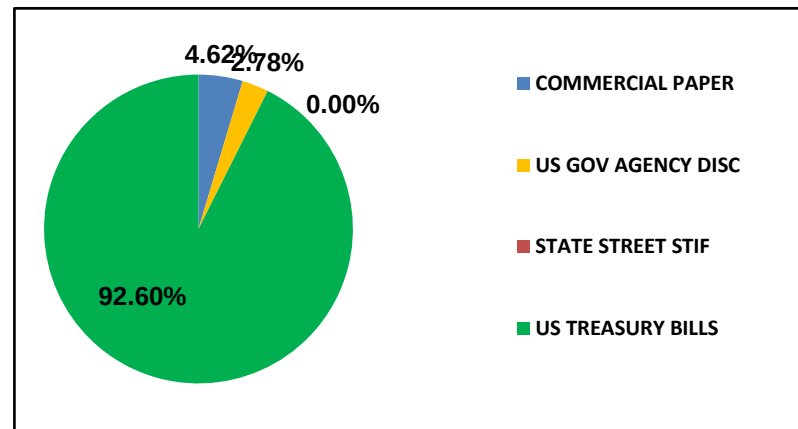
