Dear Applicant,

We are pleased to introduce the new 2024 State of New Jersey Application for Property Tax Relief for Seniors and Social Security Disability Recipients.

For the first time, New Jersey residents can **apply** for three major property tax relief programs on **a single application** – **Form PAS-1.** This easy-to-use form is available for seniors as well as homeowners and mobile home owners who are disabled. You can apply for these programs: Property Tax Reimbursement (Senior Freeze); Affordable New Jersey Communities for Homeowners and Renters (ANCHOR); and Stay NJ.

This one-stop application can be used by resident homeowners, mobile home owners and renters age 65 and over – and those who are receiving federal Social Security Disability benefits. It replaces the previous Senior Freeze forms (PTR-1 and PTR-2) and ANCHOR applications. **You will no longer be required to file separate applications** to receive benefits from these State programs. The State will determine which programs you are eligible for and calculate the benefits you are entitled to receive.

You also have the **option to file** the combined application **online**. The advantages of filing online are that you will receive a reference number after filing, and be able to sign up for direct deposit. You can also start the application and finish it on another day without losing any information. Get started by visiting our website at *propertytaxrelief.nj.gov*.

If you previously received benefits from Senior Freeze, ANCHOR – or both – there are notable changes to this year's application. For Senior Freeze recipients, the application looks different, and the income standards have changed. You also no longer have to include proof of property taxes paid with the application. If you already have a "base year," it will be printed on line 13 for homeowners, or line 21 for mobile home owners.

For Senior Freeze, the total annual income limits are:

- For 2023 \$163,050 or less, and
- For 2024 \$168,268 or less

For ANCHOR homeowner recipients, you no longer need an Identification Number and PIN to file for benefits. (Eligibility requirements, including income limits, and benefits available for property tax relief programs, are subject to change by the State Budget.)

By late 2025, we will send a letter to combined application filers to explain the Senior Freeze, ANCHOR and Stay NJ benefit amounts calculated for each applicant. We expect to begin distributing benefit payments in the second half of 2025 on a rolling basis. Please note the availability of these programs is subject to annual State Budget appropriations.

Application for Property Tax Relief For Seniors and Social Security Disability Recipients

Introduction

This booklet contains a combined application for New Jersey's property tax relief programs for homeowners and renters age 65 or older and those who were receiving Social Security Disability benefits on December 31, 2024.

If you are under 65 and not receiving Social Security Disability benefits, do not complete this application. You will be able to apply for the ANCHOR program in the summer of 2025.

This combined application incorporates the three major programs available to senior and disabled individuals:

- Property Tax Reimbursement (Senior Freeze);
- Affordable New Jersey Communities for Homeowners and Renters (ANCHOR);
- Stay NJ.

There are no longer separate applications for the various programs.

To receive benefits, you must complete the application and submit it with any required documents by October 31, 2025. Once you file, the Division of Taxation will determine which programs you qualify for and the amount of each benefit. Benefits for all of the programs included in this Property Tax Relief application are subject to State Budget appropriation.

You may be required to submit documentation at a later date to verify your age/disability status, rent, property taxes or P.I.L.O.T. (Payments-in-Lieu-of Tax), and/or mobile home park site fees.

Prior Senior Freeze Recipients. You will notice some changes. Not only does the application look different, but the income standards have changed, and you are no longer required to submit proof of property taxes or mobile home park site fees with the application. Since the Division will determine the amount of the benefits received for each program, you will no longer need to calculate your reimbursement.

For homeowners, your "Base Year" property taxes will be preprinted on line 13. For mobile home owners, your "Base Year" property taxes (18% of site fees) will be preprinted on line 21.

Prior ANCHOR Homeowner Recipients. You are no longer required to have an Identification Number and PIN to file for benefits.

Spouse/Civil Union Partner. Any reference in this booklet to a spouse also refers to a spouse who entered into a valid same-sex marriage in another state or foreign nation and a partner in a civil union (CU) recognized under New Jersey law.

Impact of State Budget

Eligibility requirements, including income limits, and benefits available for all New Jersey property tax relief programs are subject to change by the State Budget.

Any changes to the eligibility requirements and benefit amounts for 2024 will not be finalized until the completion of the State Budget, which must be adopted by July 1, 2025.

How to File

Eligible applicants can file the 2024 Application for Property Tax Relief online at propertytaxrelief.nj.gov or by paper, using the form in this booklet.

When To File

File your application by October 31, 2025. All paper applications postmarked on or before the due date are considered filed on time. Online applications must be submitted by 11:59 p.m., October 31, 2025.

Eligibility

This combined application is for the three major property tax relief programs available in New Jersey: Property Tax Reimbursement (Senior Freeze), ANCHOR, and Stay NJ. Each program has different eligibility requirements. However, you may be eligible for property tax relief if:

- · You met certain income limits; and
- You were a New Jersey resident who lived in the same home for all of 2024 or you owned (or rented) and occupied a home in New Jersey that was your principal residence (main home) on October 1, 2024.

For more information about the specific eligibility requirements for each property tax relief program, visit the Division's website at: propertytaxrelief.nj.gov

Principal residence (main home) means a home you occupied as your permanent residence. You are not eligible for a benefit for a vacation home, a "second home," or a property you owned and rented to someone else. If you occupied more than one property in New Jersey, only file the application for the property that was your main home on October 1, 2024.

Residents of condominiums, co-ops, and continuing care retirement facilities who meet the eligibility requirements are also eligible for this benefit.

Life Estate (Life Tenancy). You are considered the owner of the property if you have life estate rights or hold a lease for 99 years or more. You must include a copy of an official document (e.g., deed, lease) establishing your right to occupy the property with your application the first time you apply for property tax relief. You do not need to include this documentation every year.

Property Owned by Trust. You are considered an eligible owner of a property owned by a trust if you are a beneficiary, or the deed or trust agreement explicitly states that you have a life estate in the property. You must submit a complete copy of the trust agreement and a copy of the deed with your application the first time you apply for property tax relief. You do not need to include this documentation every year.

Privacy Act Notification

The federal Privacy Act of 1974 requires an agency requesting information from individuals to inform them why the request is being made and how the information is being used.

The Division of Taxation uses your Social Security number primarily to account for and give credit for tax payments. We also use Social Security numbers in the administration and enforcement of all tax laws for which we are responsible. In addition, the Division is required by law to forward an annual list to the Administrative Office of the Courts containing the names, addresses, and Social Security numbers of individuals who file a New Jersey tax return or property tax benefit application. This list will be used to avoid duplication of names on jury lists.

Completing the Application

Deceased applicants see page 11 for instructions.

Social Security Number(s)

Enter your Social Security number or Individual Taxpayer Identification number (ITIN) in the boxes at the top of the application, one digit in each box. If you are married or in a civil union, you must enter the Social Security numbers or ITINs for both of you. Enter the numbers in the same order they are entered on the NJ-1040 (even if only one spouse holds title to the property) unless you maintained separate main homes on October 1, 2024.

If you (or your spouse) do not have a Social Security number, file Form SS-5 with the Social Security Administration to apply for one. If you are not eligible for a Social Security number, you must file Form W-7 with the Internal Revenue Service to get an individual taxpayer identification number (ITIN) and enter your ITIN in the boxes provided for your Social Security number. If you applied for but have not received an ITIN by the due date, enclose a copy of your federal Form W-7 application with this form.

County/Municipality Code

Enter the four-digit code for your current residence, one digit in each box, from the table on page 13.

Name and Address

Print or type your name (last name first), current mailing address, and ZIP Code in the spaces provided. Include your spouse's name unless you are filing separate applications.

Prior Senior Freeze Recipients. Your name and mailing address are preprinted on your PAS-1 application. If your mailing address is incorrect, draw a line through it and enter the correct information.

Address of Main Home on October 1, 2024

Enter the street address and county/municipality code of the New Jersey residence you occupied on October 1, 2024, if it is different from the address at the top of the application.

Filing Status

Line 1. Fill in the oval that corresponds to your filing status on your 2024 New Jersey Income Tax return. Using a filing status that is different than the filing status used on your 2024 return may delay your benefits. If you were not required to file a return, enter the filing status you would have used if you had filed. Fill in only one oval.

Head of Household. You can use this filing status if you were unmarried or not a partner in a civil union on the last day of the tax year, and you paid more than one-half of the cost of keeping up a home for yourself and at least one qualifying person. Certain married individuals/civil union partners living apart can file as head of household for New Jersey if they meet the requirements to file as head of household for federal purposes. You may also qualify to file as head of household if you are no longer eligible to file as qualifying widow(er)/surviving CU partner, and you have not remarried or entered into a new civil union

Qualifying Widow(er)/Surviving CU Partner. You may be eligible to use this filing status for 2024 only if your spouse died in either 2022 or 2023, and you meet the other requirements to file as qualifying widow(er) for federal purposes.

Married/CU Partner, Filing Separately. If you filed your 2024 New Jersey Resident Income Tax return as "married/CU partner, filing separate return," you must indicate whether

on October 1, 2024, you and your spouse maintained the same or separate residences.

Separate Residences. If you each maintained a separate residence, you should file separate applications and fill in the oval for filing status E, "Married/CU Partner, filing separately: each maintains separate residence."

Same Residence. If you both maintained the same residence, you must file one application and fill in the oval for filing status F, "Married/CU Partner, filing separately: both maintain same residence."

Age and Disability Status

Line 2. Enter your **birth year** in the boxes on the application, one digit in each box. If you are married or in a civil union, you must enter the birth years of both spouses unless you maintained separate residences on October 1, 2024.

Line 3a. Indicate whether you were actually receiving federal Social Security disability benefit payments on or before December 31, 2023. You do not qualify if you (or your spouse) were receiving those benefits on behalf of someone else. Fill in the appropriate ovals.

Line 3b. Indicate whether you were actually receiving federal Social Security disability benefit payments on or before December 31, 2024. You do not qualify if you (or your spouse) were receiving those benefits on behalf of someone else. Fill in the appropriate ovals.

Residency Information

Line 4a. Fill in the "Yes" oval if you owned (or rented) and lived in the same main home in New Jersey for the entire year from January 1, 2024, through December 31, 2024. Then continue with line 4b. If "No," skip line 4b and continue with line 5a.

Residents of co-ops, mutual housing organizations, and continuing care retirement facilities who changed units within the same facility in 2024, fill in the "Yes" oval.

Line 4b. If you answered "Yes" at line 4a, fill in the appropriate oval to indicate your residency status for all of 2024. Fill in only one oval.

Homeowner. If you owned your main home, fill in this oval and continue with Schedule I.

Mobile Home Owner. If you occupied and leased a site in a mobile home park on which you placed a manufactured or mobile home that you owned as your main home, fill in this oval and continue with Schedule II.

Renter. If you rented your main home, fill in this oval and continue with the Signature section to complete your application.

Line 5a. Complete line 5a only if you answered "No" at line 4a. Fill in the "Yes" oval if you owned (or rented) and lived in a home in New Jersey that was your main home on October 1, 2024. Then continue with line 5b. If "No," you are not eligible for property tax relief benefits. Do not file this application.

Line 5b. If you answered "Yes" at line 5a, fill in the appropriate oval to indicate your residency status on October 1, 2024.

Homeowner. If you owned your main home, fill in this oval and continue with Schedule III.

Mobile Home Owner. If you occupied and leased a site in a mobile home park on which you placed a manufactured or mobile home that you owned as your main home, fill in this oval and continue with the Signature section to complete your application.

Renter. If you rented your main home, fill in this oval and continue with the Signature section to complete your application.

Schedule I - Homeowners

Complete this schedule only if you answered "Yes" at line 4a and indicated you were a homeowner at line 4b. Do not complete this schedule if you were a mobile home owner or renter.

Line 6. Fill in the "Yes" oval if the home you are applying for is the same home for which you filed for the ANCHOR benefit last year. If you are unsure if you filed for the ANCHOR benefit last year or have moved since filing, fill in "No."

Line 7. Fill in the "Yes" oval if you owned and lived continuously in the same home for which you are claiming benefits since December 31, 2020, or earlier. Otherwise, fill in "No."

Line 8. Fill in the "Yes" oval if you moved to your current home between January 1, 2022, and December 31, 2023. Otherwise, fill in "No."

Line 9. If you lived in a co-op or continuing care retirement facility, enter the name of the building or facility and fill in the appropriate oval.

Line 10a. Fill in the "Yes" oval only if you owned the property that was your main home with someone who was not your spouse — even if the other owners did not live there. For example, you and your sister owned the home you lived in. If you (and your spouse) were the sole owners. fill in "No."

Line 10b. If you answered "Yes" at line 10a, enter the share (percentage) of the property you (and your spouse) owned.

Example: You and your spouse owned a home with your sister. Your sister did not live with you, and you and your spouse paid all the property taxes. You must enter 50% at line 10b of your application because you and your spouse owned only one-half (50%) of

the property. If your sister also is eligible, she must file a separate application.

Line 11a. Fill in the "Yes" oval if your main home was a unit in a multi-unit property that you owned. For example, you owned a property consisting of four residential units and you occupied one of the units as your main home. If the property is not a multi-unit property, fill in "No."

"Unit of residential property" means a single, separate dwelling unit that includes complete, independent living facilities for one or more persons. This unit must contain permanent provisions for living, sleeping, eating, cooking, and sanitation, with access to a separate kitchen and bathroom.

Residents of condominium complexes, co-ops, and continuing care retirement facilities are not considered to be living in multi-unit properties and should fill in "No."

Line 11b. If you answered "Yes" at line 11a, enter the share (percentage) of the property that you (and your spouse) used as your main home.

Example: You owned a four-unit property. The units are equal in size, and one of the units was your main home. You occupied one-fourth (25%) of the property as your main home. Enter 25% at line 11b.

You do not qualify for property tax relief benefits if the property you own:

- Consists of more than four units, even if it also includes a residential unit you used as your main home; or
- Contains more than one commercial unit, even if it also includes a residential unit you used as your main home.

Property Taxes

Line 12a. Enter the block and lot numbers of your main home for all of 2024. Include

qualifier if applicable (condominiums only). You can get this information from your current property tax bill or your local tax collector.

Example: Block 3105.62 Lot 14.3

Line 12b. Fill in the "Yes" oval if the property spans more than one lot or is located in more than one municipality, or if you were billed for property taxes on any other nearby unoccupied lots that you use for residential purposes (e.g., an empty lot used as a yard, a lot with a garage or parking space). Otherwise, fill in "No." Include taxes billed on the additional lots on lines 13 and 14.

Line 13, 14, and 15. If you owned your home with someone who was not your spouse, or you lived in a multi-unit property, use the percentage entered at line 10b or 11b to calculate your proportionate share of the property taxes and P.I.L.O.T.

Line 13. Enter your total property taxes billed for your main home in New Jersey for 2023. Include amounts for any additional lots indicated at line 12b. Do not include any amounts billed under a P.I.L.O.T. agreement on this line.

Prior Senior Freeze recipients. Line 13 has been preprinted with your "Base Year" property taxes. If the amount is incorrect, draw a line through it and enter the correct amount in the space to the left of the boxes. If there is no amount, enter the correct amount in the boxes.

Line 14. Enter your total property taxes billed for your main home in New Jersey for 2024. Include amounts for any additional lots indicated at line 12b. Do not include any amounts billed under a P.I.L.O.T. agreement on this line.

Disabled Veteran. If you (or your spouse) are a totally and permanently disabled veteran who received a 100% exemption from local property taxes in 2024, you are not eligible for property tax relief benefits, even if a portion of the property was rented to a tenant and property taxes were paid on the rented portion.

Line 15a. If you had a P.I.L.O.T. agreement with your municipality during 2024, fill in the "Yes" oval and continue with line 15b. If "No," continue with line 16.

Line 15b. If you answered "Yes" at line 15a, enter your amount of P.I.L.O.T. due to your municipality for 2024.

Income

To calculate the income to report on lines 16 and 17, complete Worksheets A and B using information from your 2023 and 2024 Forms NJ-1040, SSA-1099, and any other relevant documents.

If you are not required to file Form NJ-1040, complete Worksheet A and Worksheet B with amounts you would have reported if you did file the return. For more information, see the NJ-1040, Resident Income Tax Return, instructions at www.nj.gov/treasury/taxation/pdf/current/1040i.pdf

Line 16. Enter your 2023 total income from Worksheet A, line e.

Line 17. Enter your 2024 total income from Worksheet B, line e.

Worksheet A and Worksheet B

Use the amounts from the appropriate year on the corresponding worksheets.

Spouses who filed separately but maintained the same main home must enter combined income.

2024 Form PAS-1 instructions

If you and your spouse were living apart and you did not have access to or receive support from your spouse's income, include only your own income on the worksheets.

If your spouse died in 2023 or 2024, include only your own income on the worksheet for that year. For more information, see Deceased Applicants on page 11.

Line a. Enter the amount from line 27, Form NJ-1040.

Line b. Enter the amount from line 16b, Form NJ-1040. Do not include any amounts from line 16a.

Line c. Include the following:

- The amount from line 20b, Form NJ-1040.
 This is the portion of the total distribution that was not reported on line 20a. Do not include any amounts from line 20a.
- Any amounts received as a total and permanent disability pension before you reached age 65. (This amount is not reported on Form NJ-1040.)
- The amount of any qualified distribution from a Roth IRA or the amount rolled over from a Roth IRA to another Roth IRA. (These amounts are not reported on Form NJ-1040.)

Line d. Enter the total amount of Social Security benefits (including Medicare Part B premiums) from Box 5 of Form SSA-1099.

Schedule II - Mobile Home Owners

Complete this schedule only if you answered "Yes" at line 4a and indicated you were a mobile home owner at line 4b. Do not complete this schedule if you were a homeowner or renter.

Line 18. Fill in the "Yes" oval if you owned and lived in a mobile home on the same site as the site you occupied on December 31, 2020, or earlier. Otherwise, fill in "No."

Line 19. Fill in the "Yes" oval if you moved to your current home between January 1, 2022, and December 31, 2023. Otherwise, fill in "No."

Line 20a. Fill in the "Yes" oval only if you occupied the property that was your main home with someone who was not your spouse and

shared site fees with them. If you (and your spouse) were the sole occupant(s), fill in "No."

Line 20b. If you answered "Yes" at line 20a, enter your share (percentage) of the site fees.

Line 21 and Line 22. For mobile home owners, property taxes are 18% of the annual site fees due to the owner of the mobile home park. If you lived with someone who was not your spouse and shared the site fees with them, use the percentage entered at line 20b to calculate your proportionate share of the site fees.

Line 21. Multiply the amount of your site fees due for 2023 by 18% (0.18) and enter the result in the boxes at line 21.

Prior Senior Freeze recipients. Line 21 has been preprinted with your "Base Year" property taxes (18% of site fees). If the amount is incorrect, draw a line through it and enter the correct amount in the space to the left of the boxes. If there is no amount, enter the correct amount in the boxes.

Line 22. Multiply the amount of your site fees due for 2024 by 18% (0.18) and enter the result in the boxes at line 22.

Income

To calculate the income to report on lines 23 and 24, complete Worksheets C and D using information from your 2023 and 2024 Forms NJ-1040, SSA-1099, and any other relevant documents.

If you are not required to file Form NJ-1040, complete Worksheet C and Worksheet D with amounts you would have reported if you did file the return. For more information, see the NJ-1040, Resident Income Tax Return, instructions at www.nj.gov/treasury/taxation/pdf/current/1040i.pdf

Line 23. Enter your 2023 total income from Worksheet C, line e.

Line 24. Enter your 2024 total income from Worksheet D, line e.

Worksheet C and Worksheet D

Use the amounts from the appropriate year on the corresponding worksheets.

Spouses who filed separately but maintained the same main home must enter combined income.

If you and your spouse were living apart and you did not have access to or receive support from your spouse's income, include only your own income on the worksheets.

If your spouse died in 2023 or 2024, include only your own income on the worksheet for that year. For more information, see Deceased Applicants on page 11.

Line a. Enter the amount from line 27, Form NJ-1040.

Line b. Enter the amount from line 16b, Form NJ-1040. Do not include any amounts from line 16a.

Line c. Include the following:

- The amount from line 20b, Form NJ-1040.
 This is the portion of the total distribution that was not reported on line 20a. Do not include any amounts from line 20a.
- Any amounts received as a total and permanent disability pension before you reached age 65. (This amount is not reported on Form NJ-1040.)
- The amount of any qualified distribution from a Roth IRA or the amount rolled over from a Roth IRA to another Roth IRA. (These amounts are not reported on Form NJ-1040.)

Line d. Enter the total amount of Social Security benefits (including Medicare Part B premiums) from Box 5 of Form SSA-1099.

Schedule III - Certain Homeowners

Complete this schedule only if you answered "Yes" at line 5a and indicated you were a homeowner at line 5b. Do not complete this schedule if you were a mobile home owner or renter.

Line 25. Fill in the "Yes" oval if the home you are applying for is the same home for which you filed for the ANCHOR benefit last year. If you are unsure if you filed for the ANCHOR benefit last year or have moved since filing, fill in "No."

Line 26. If you lived in a co-op or continuing care retirement facility, enter the name of the building or facility and fill in the appropriate oval.

Line 27a. Fill in the "Yes" oval only if you owned the property that was your main home

with someone who was not your spouse — even if the other owners did not live there. For example, you and your sister owned the home you lived in. If you (and your spouse) were the sole owners, fill in "No."

Line 27b. If you answered "Yes" at line 27a, enter the share (percentage) of the property you (and your spouse) owned.

Example: You and your spouse owned a home with your sister. Your sister did not live with you, and you and your spouse paid all the property taxes. You must enter 50% at line 27b of your application because you and your spouse owned only one-half (50%) of the property. If your sister also is eligible, she must file a separate application.

Line 28a. Fill in the "Yes" oval if your main home was a unit in a multi-unit property that you owned. For example, you owned a property consisting of four residential units and you occupied one of the units as your main home. If the property is not a multi-unit property, fill in "No."

"Unit of residential property" means a single, separate dwelling unit that includes complete, independent living facilities for one or more persons. This unit must contain permanent provisions for living, sleeping, eating, cooking, and sanitation, with access to a separate kitchen and bathroom.

Residents of condominium complexes, co-ops, and continuing care retirement facilities are not considered to be living in multi-unit properties and should fill in "No."

Line 28b. If you answered "Yes" at line 28a, enter the share (percentage) of the property that you (and your spouse) used as your main home.

Example: You owned a four-unit property. The units are equal in size, and one of the units was your main home. You occupied one-fourth

(25%) of the property as your main home. Enter 25% at line 28b.

You do not qualify for property tax relief benefits if the property you own:

- Consists of more than four units, even if it also includes a residential unit you used as your main home; or
- Contains more than one commercial unit, even if it also includes a residential unit you used as your main home.

Line 29. Enter the block and lot numbers of your main home on October 1, 2024. Include qualifier if applicable (condominiums only). You can get this information from the property tax bill or tax collector.

Signature

Signatures and the date must be in blue or black ink. The signatures on the application must be original; photocopied signatures are not acceptable. We cannot process an application without the proper signatures and will return it to you. This can delay your payments.

Daytime Phone Number and/or Email

Address. Providing your daytime phone number and/or email address may help us process your application if we have questions. If you are filing a joint application, you can enter either your or your spouse's daytime phone number and/or email address.

Tax Preparers. Anyone who prepares an application for a fee must sign the application as a "Paid Preparer" and enter their Social Security number or federal preparer tax identification number. Include the company or corporation name and federal identification number if applicable. A tax preparer who fails to sign the application or provide a tax

identification number may incur a \$25 penalty for each omission. Someone who prepares your application but does not charge you should not sign your application.

Where to Send Your Application

When you have completed and signed your application, use the envelope provided in the booklet to mail the application and required documentation to:

Send only one application per envelope, even if several people in the same house (e.g., multiple owners) are filing applications.

Deceased Applicants

If a person met the eligibility requirements but died before filing an application, either the surviving spouse or a personal representative (executor or administrator of an estate, or anyone who is in charge of the decedent's personal property) can file the application. Follow the instructions to ensure that we issue the benefit payments correctly.

Name and Address

Widow(er)/surviving civil union partner. If your spouse died during 2023 or after, you must:

- Enter only your name on this application, even if your filing status is married/CU couple, filing joint return or married/CU partner or filing separately: both maintain same residence; and
- Enclose copies of the death certificate and your Social Security card.

Personal Representative. If you are filing on behalf of an eligible applicant who died on or after October 1, 2024, you must:

2024 Form PAS-1 instructions

- Enter the deceased person's last name, followed by "estate of" and the decedent's first name; and
- Enter the current mailing address; and
- Enclose a copy of the death certificate.

Income

Widow(er)/surviving civil union partner If your spouse died in 2023, report only your own income for 2023, even if you filed a joint NJ-1040.

If your spouse died in 2024, report your joint income for 2023. Report only your own income for 2024, even if you filed a joint NJ-1040.

Personal Representative

If the applicant died in 2023, do not file this application even if you filed an NJ-1040. The decedent is not eligible.

If the applicant died on or after October 1, 2024, report the income for all of 2023 and 2024. (If the applicant died prior to October 1, 2024, the decedent is not eligible.)

Signatures

Personal Representative. A personal representative filing on behalf of a deceased applicant must sign in their official capacity. If it is a joint application, the surviving spouse must also sign.

No Personal Representative. If filing a joint application when there is no personal representative for the deceased applicant, the spouse signs the application and writes "Filing as Surviving Spouse" or "Filing as Surviving Civil Union Partner" in the Signature section. If there is no personal representative and no surviving spouse, the person in charge of the decedent's property must file and sign as "personal representative."

Check the box above the signature line and enclose a copy of the decedent's death certificate.

Payments will be issued in the name of the widow(er)/surviving civil union partner or the name of the estate entered on the form. Payments cannot be issued in the name of the executor, administrator, or personal representative.
