ITEM OF DISCUSSION

1. Resolution of the New Jersey Educational Facilities Authority Appointing an Executive Director and Secretary of the Authority

Mr. Hodes presented a resolution appointing Eric D. Brophy as Executive Director and Secretary of the Authority. Mr. Hodes stated that Mr. Brophy had been a practicing attorney in the private sector for nearly 20 years and that most recently he was with Diegnan & Brophy, LLC in Wall Township, New Jersey where he served as Managing Member of its business litigation practice. The practice emphasized representation of businesses and individuals both asserting and defending business claims and included, among other areas, broad representation of governmental entities and prosecution of municipal court matters.

Mr. Brophy has had extensive community and civic involvement, including service as a Member and Board President of the Wall Township Board of Education, a Member of the University of Scranton Alumni Board of Governors, a Member of Seton Hall School of Law Alumni Council, and President of the Wall Township Chamber of Commerce. He holds a Bachelor of Science in Criminal Justice from the University of Scranton, a Juris Doctor from the Seton Hall University School of Law and a Graduate Certificate - Masters of Public Administration from Rutgers University.

Mr. Hodes thanked Ms. Stitt for maintaining the day-to-day operations of the Authority over the past year. Mr. Hodes stated that he looked forward to working with Mr. Brophy and Ms. Stitt going forward.

Mr. Rodriguez moved the adoption of the following entitled resolution:

RESOLUTION OF THE NEW JERSEY EDUCATIONAL FACILITIES AUTHORITY APPOINTING AN EXECUTIVE DIRECTOR AND SECRETARY OF THE AUTHORITY

Adopted: September 6, 2018

WHEREAS:

The New Jersey Educational Facilities Authority (the "Authority") was created pursuant to the New Jersey Educational Facilities Authority Law, L. 1967, c. 271, N.J.S.A. 18A:72A-1 et seq., as amended and supplemented (the "Act") and authorized to issue its obligations to provide a means for New Jersey public and private colleges and universities to obtain financing to construct educational facilities as defined in the Act; and

WHEREAS:

The Executive Director is an Officer of the Authority, appointed by the Authority, and serving as the chief executive officer of the Authority, with general supervision of, and administrative authority over, all of the activities of the Authority; and

WHEREAS:

The office of the Executive Director has been vacant since August 31, 2017, when Jeremy A. Spector resigned that position; and

WHEREAS:

The Members of the Authority have not made a formal appointment of an Executive Director since that time. Rather, to manage the day-to-day operations of the Authority, the Members of the Authority appointed Sheryl A. Stitt to serve as Acting Executive Director and Acting Secretary of the Authority, and Ms. Stitt is currently serving in that role; and

WHEREAS:

The Members of the Authority, in accordance with the Act and the By-Laws of the Authority, as amended through November 30, 2017 (the "By-Laws"), desire to appoint Eric D. Brophy, Esq. as the Executive Director of the Authority; and

WHEREAS:

The Members further wish that the duties and responsibilities of the Secretary as set forth in the By-Laws be vested in the Executive Director; and

WHEREAS:

Accordingly, in addition to the position of Executive Director, the Members also desire to appoint Mr. Brophy as the Secretary of the Authority.

NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE NEW JERSEY EDUCATIONAL FACILITIES AUTHORITY AS FOLLOWS:

- SECTION 1. The Members hereby appoint Eric D. Brophy, Esq. as the Executive Director of the Authority at an initial annual salary of \$141,000.00 to perform the functions of that office with all duties, responsibilities and authority granted to that office pursuant to the Act, the By-Laws, resolutions of the Members and other applicable laws and regulations.
- SECTION 2. The Members of the Authority hereby appoint Eric D. Brophy, Esq. as the Secretary of the Authority with the duties and responsibilities of that office set forth in the Act and By-Laws.
- **SECTION 3.** This Resolution shall take effect in accordance with the Act and replaces all prior resolutions to the extent inconsistent herewith.
