**Re: OPRA request received February 15, 2024**

Dear Mr. Weisenbach:

The New Jersey Educational Facilities Authority (“NJEFA” or the “Authority”) received your response to the Authority’s request for clarification on February 23, 2024, and has completed its review of your Open Public Records Act (“OPRA”) request.

Your clarified OPRA request sought access to the following:

- 1. Any documents containing information related to The College of New Jersey that would be reported in the 2023 or 2024 NJEFA Annual Report.*
- 2. Any active applications filed by The College of New Jersey to request funding from the NJEFA.*
- 3. Any bond prospectus for any NJEFA-funded projects with The College of New Jersey in the last two years.*
- 4. Any OPRA requests received and fulfilled by NJEFA regarding The College of New Jersey within the last two years.*

As the Records Custodian for NJEFA, I am providing the following response.

As to the first portion of your request seeking “any documents containing information related to The College of New Jersey that would be reported in the 2023 or 2024 NJEFA Annual Report,” the Authority has not yet completed the annual reports for 2023 and 2024. Therefore, the Authority is unable to identify the records you have requested at this time.

As to the second portion of your request seeking “any active applications filed by The College of New Jersey to request funding from the NJEFA,” the Authority does not currently have any active applications from The College of New Jersey. Therefore, the Authority does not possess the records you have requested.

As to the third portion of your request seeking, “any bond prospectus for any NJEFA-funded projects with The College of New Jersey in the last two years,” bond prospectus related to NJEFA-funded projects with The College of New Jersey in the last two years can be found on Electronic Municipal Market Access (“EMMA”) website. 
As to the fourth portion of your request seeking, “any OPRA requests received and fulfilled by NJEFA regarding The College of New Jersey within the last two years,” the Authority has not received any OPRA requests related to The College of New Jersey in the last two years. Therefore, the Authority does not possess the records you have requested.

As this response acts to produce all identifiable records that are releasable under OPRA, NJEFA considers your OPRA request satisfied and closed.

At your option, you may either institute a proceeding in the Superior Court of New Jersey or file a complaint with the Government Records Council (GRC) by completing the Denial of Access Complaint Form.
